RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE FEBRUARY 3, 2007 SUPER BOWL FEST 2007 SPONSORED BY THE HATIAN WOMEN OF MIAMI IN PARTNERSHIP WITH THE CITY OF NORTH MIAMI, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$805.00 TO BE FUNDED FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT BUDGET

WHEREAS, the Hatian Women of Miami in partnership with the City of North Miami have requested in-kind services from the Miami-Dade Fire Rescue Department for the February 3, 2007 Super Bowl Fest 2007 in an amount not to exceed \$805.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the Hatian Women of Miami is a non-for-profit organization; and

WHEREAS, the Super Bowl Fest 2007 is a special event, as defined in the attached Fee Waiver/In-kind Service Application, and the purpose of the event is to bring together the community of North Miami for an afternoon of entertainment on the verge of the Super Bowl XLI; and

WHEREAS, the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District Budget,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Fire Rescue Department for the February 3, 2007 Super Bowl Fest 2007 in an amount not to exceed \$805.00 to be funded from the non-ad valorem portion of the Fire Rescue District Budget.





Subject: In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Haitian Women of Miami, FAHM in partnership with the City of North Miami for their Super Bowl Fest 2007 scheduled for February 3, 2007.

In-kind services have been requested in an amount not to exceed \$805 from the Miami-Dade Fire Rescue Department (MDFR) for EMS services. This event does not affect the countywide in-kind reserve fund.

In FY 2006-07 Haitian Women of Miami has not received any County funding.
