**RESOLUTION RELATING TO COMMUNITY COUNCILS;
PROVIDING FOR THE DISSOLUTION OF SUBAREA 86 AND
THE CREATION OF AN AT-LARGE SEAT IN NORTH
CENTRAL COMMUNITY COUNCIL EIGHT**

WHEREAS, Section 20-42(C) of the Code of Miami-Dade County provides that the boundaries of Community Councils may be amended from time to time by resolution of the County Commission and after public hearing; and

WHEREAS, Community Council Eight (8) Subarea 86 has been vacant since October 13, 2006; and

WHEREAS, on multiple occasions there has been a substantial effort to identify potential candidates for Subarea 86 to no avail; and

WHEREAS, the elimination of Subarea 86 will create the need for an at-large seat in Community Council Eight,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the North Central Community Council Eight (8) is reconfigured as indicated in Attachment A, to eliminate Subarea 86 and to provide for an At-Large seat.

The foregoing resolution was sponsored by Commissioner Dorrin D. Rolle and offered by Commissioner Rebeca Sosa, who moved its adoption. The motion was seconded by Commissioner Dennis C. Moss and upon being put to a vote, the vote was as follows:
