RESOLUTION APPROVING AN ALLOCATION TO FOR KIDS SHAPE BY PEDS POWER, A FOR-PROFIT ORGANIZATION, IN THE AMOUNT OF \$5,000 FROM THE DISTRICT 4 DISCRETIONARY RESERVE FUND FOR FISCAL YEAR 2006-2007

WHEREAS, For Kids Shape by Peds Power, a for-profit organization, manages a program designed by Peds Power Nutrition and Fitness Center to address the nutrition, fitness, and mental health goals of children 6-11 years of age and in financial need; and

WHEREAS, For Kids Shape by Peds Power focuses on health and fitness in an effort to encourage healthful eating habits and weight control, participation in regular physical activity, positive self esteem and reduction in risk of chronic disease; and

WHEREAS, participants in the program are selected by pediatricians in Miami-Dade County and must meet certain criteria – an elevated body mass of more than 85 percent, inactivity, elevated cholesterol, diabetes, hypertension, and financial need; and

WHEREAS, qualified children participate in a ten-week program designed to improve their quality of life and that of their parents,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board approves the allocation of FY 2006-2007 District 4 Discretionary Reserve Funds to For Kids Shape by Peds Power in the amount of \$5,000 to be used for the nutrition and fitness program for low income children that would not otherwise have the means to be a part of this program.
