RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MARCH 3, 2007 AZUCAR AWARDS SPONSORED BY THE UNITY COALITION OF MIAMI-DADE, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,000.00 TO BE FUNDED FROM THE DISTRICT 5 IN-KIND RESERVE FUND

WHEREAS, the Unity Coalition of Miami-Dade, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the March 3, 2007 Azucar Awards in an amount not to exceed \$4,000.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the Unity Coalition of Miami-Dade, Inc. is a not-for-profit organization; and

WHEREAS, the Azucar Awards is a special event, as defined in the attached Fee Waiver/In-kind Service Application, and the purpose of the event is to present awards to local media, community-based organizations, and individuals; and

WHEREAS, the in-kind services shall be funded from the District 5 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the March 3, 2007 Azucar Awards in an amount not to exceed \$4,000.00 to be funded from the District 5 In-kind Reserve Fund.







Subject: Direct Specific In-Kind Reserve Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Unity Coalition of Miami, Inc. for their Azucar Awards held on March 3, 2007 at the Miami-Dade County Auditorium.

In-kind services have been requested in an amount not to exceed \$4,000 from the Park and Recreation Department for the waiver of rental fees for the auditorium. This event will be funded from District 5's district specific in-kind reserve.

In FY 2006-07 the Unity Coalition of Miami, Inc. has not received any county funding for this event.
