RESOLUTION AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT AND THE MIAMI-DADE POLICE DEPARTMENT FOR THE APRIL 28, 2007 WALK AMERICA SPONSORED BY THE MARCH OF DIMES, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$25,869.60 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

WHEREAS, the March of Dimes has requested in-kind services from the Miami-Dade Park and Recreation Department and the Miami-Dade Police Department for the April 28, 2007 Walk America in an amount not to exceed \$25,869.60 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, Walk America is a fundraiser walk to raise money to improve the health of babies by reducing the incidence of birth defects, premature births, and infant mortality; and

WHEREAS, the March of Dimes is a not-for-profit organization; and

WHEREAS, Walk America is a major event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the Countywide In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department and the Miami-Dade Police Department for the April 28, 2007 Walk America in an amount not to exceed \$25,869.60 to be funded from the Countywide In-kind Reserve Fund.

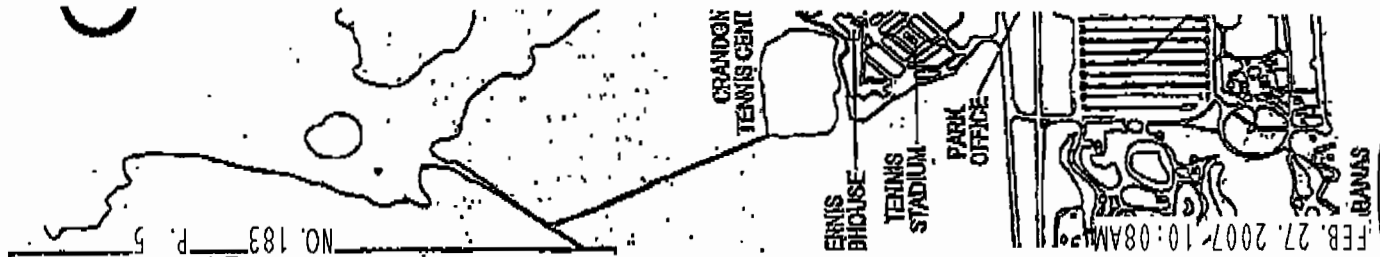

Subject: Countywide In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide-in-kind reserve balance allows for the funding of this request.

Background

A waiver for in-kind services is being requested by a not-for-profit organization March of Dimes for their 2007 Walk America fundraiser to be held on April 28, 2007.

In-kind services have been requested in an amount not to exceed \$10,300 from the Miami-Dade Police Department for police services and \$15,569.60 from the Park and Recreation Department for Crandon Park fees for a total in-kind amount of \$25,869.60. This event will be funded from the countywide in-kind reserve fund.

In FY 2006-07 the March of Dimes has not received any County funding.
