RESOLUTION APPROVING THE PLAT OF SERRANO'S WAREHOUSE, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 21, TOWNSHIP 53 SOUTH, RANGE 41 EAST (NW 37 STREET AND NW 34 AVENUE)

WHEREAS, Jesus Serrano and Alicia P. Serrano, his wife, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as SERRANO'S WAREHOUSE, the same being a replat of Lot 14, Block 4 and a portion of a tract designated as "Public Park" of "36th Street Highlands", according to the plat thereof, as recorded in Plat Book 22, at Page 73, of the Public Records of Miami-Dade County, Florida, lying and being in the SW 1/4 of Section 21, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.





BACKGROUND

SERRANO'S WAREHOUSE (T-21825)

- Located in Section 21, Township 53 South, Range 41 East
- Commission District: 3
- Zoning: IU-2
- Proposed Usage: Warehouse
- Number of parcels: 1

PLAT RESTRICTIONS

- That the Street, as shown on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon are hereby dedicated to the perpetual use of

the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof, whenever discontinued by law.

- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use in accordance with County and State regulations.
- That all new electric and communication lines may be installed overhead, service conductors from the pole to the building (structure) shall be an underground service lateral.
- That the utility easement, as shown by dashed lines on the plat, is hereby reserved for the installation and maintenance of public utilities.
