RESOLUTION NO. R-41-07

RESOLUTION AUTHORIZING THE COUNTY MANAGER TO AMEND THE FY 1994-FY 2006 ACTION PLANS TO REFLECT THE REALLOCATION OF \$4,737,734 IN CDBG FUNDS, AS INDICATED IN EXHIBIT I; AUTHORIZING THE COUNTY MANAGER TO EXECUTE ALL CONTRACTS, AGREEMENTS AND AMENDMENTS NECESSARY TO CARRY OUT THE ABOVE PROGRAM; AND AUTHORIZING THE COUNTY MANAGER TO EXERCISE THE CANCELLATION PROVISIONS CONTAINED THEREIN AND AUTHORIZING REIMBURSEMENT OF ALL ONGOING EXPENDITURES INCURRED EFFECTIVE WITH THE BEGINNING OF THE ACTION PLAN YEAR AND THE PROPOSED CDBG RESERVE BE INCORPORATED IN THE APPROVAL OF FUNDING RECOMMENDATIONS FOR FY 2007 ACTION PLAN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the County Manager to amend the FY 1994-FY 2006 Action Plans to reflect the reallocation of \$4,737,734 CDBG funds, as indicated in Exhibit I; and that the proposed CDBG reserve be incorporated in the approval of funding recommendations for FY 2007 Action Plan and authorizes the County Manager to execute such contracts, agreements and amendments as are required following approval by the County Attorney's Office and subject to proper execution by the parties; and to exercise the cancellation provisions contained therein.

The foregoing resolution was offered by Commissioner Sen. Javier D. Souto, who moved its adoption. The motion was seconded by Commissioner Jose "Pepe" Diaz and upon being put to a vote, the vote was as follows:

The item was amended at the Community Empowerment and Economic Revitalization (CEER) Committee meeting of November 27, 2006. This item was amended to remove Commission District Reserve Funds in the amount of \$207,000 which will be processed as a separate item for Board Consideration. the revised amount of recaptured and reallocated funds are illustrated in Exhibit 1. In addition, this item clarifies under the "Sources of Funds" section that the amended Action Plan years are from 1994 through 2006.

RECOMMENDATION

It is recommended that the Board of County Commissioners (BCC) authorize the County Manager to amend the FY 2006 Action Plan to recapture unexpended funds from prior year projects and reallocate \$ 4,737,734 of Community Development Block Grant (CDBG), as indicated in the attached Exhibit I.

BACKGROUND

The BCC approved the FY 2006 Action Plan on January 24, 2006 through Resolution R-131-06. Throughout the year, funded activities were tracked for compliance; and as a result, funds from completed activities or those activities that are no longer feasible have been identified for recapture and recommended for reallocation to meet the needs of on-going initiatives. In addition, staff recommends that the recaptures and the funding adjustments be reflected in the FY 2006 Action Plan to ensure compliance with the U.S. Department of Housing and Urban Development's (US HUD's) spending ratio for the FY 2006 entitlement year.

Of the recaptured funds, \$3,948,734 is being set aside in a CDBG District Reserve for reallocation through the FY 2007 Action Plan, \$389,000 is recommended for reallocation to activities identified by Community Advisory Committees, and \$400,000 is being reallocated to activities with funding shortfalls that can address high priority needs in the community, as indicated in Exhibit 1.

SOURCES OF FUNDS

A total of \$4,737,734 worth of FY 1994 through FY 2006 of CDBG funding is recommended for recapture. A general description of the recaptured activities or additional resources is as follows:

- Recapture from 90 completed Public Service activities that remained with unexpended balances after the financial closeout (\$828,206);
- Recapture from activities that could not be carried out due to CDBG eligibility issues and or capacity issues (\$1,118,952);
- Recapture from activities that had CDBG eligibility issues and swapped with funds from the Capital Outlay Reserve and Countywide General Fund (\$1,005,057);
- Recapture from completed non-Public Service activities that remained with unexpended balances after closeout (\$107,872);

- Recapture from activities where the recipient entity did not wish to utilize CDBG funds to carry out the activity and therefore a contract with the County did not exist (\$545,250);
- Recapture from previously funded Community Action Committee (CAC) activities to new CAC identified projects (\$339,000) plus an additional \$50,000 in program income will replace CAC funds recaptured in a previous plan amendment for a CAC funded priority in Leisure City/Naranja/Princeton NRSA;
- Recapture of \$416,000 from Commission District Funds to be made available in the FY 2007 Action Plan;
- From activities with a balance of less than \$1,000 (\$27,397); and
- Additional CDBG program income received by the County (\$350,000).

REDISTRIBUTION OF FUNDS

Miami-Dade Office of Community and Economic Development (OCED) CDBG Reserve (\$3,948,734)
Recommended recaptured funds will be incorporated into the CDBG reserve for allocation in the FY 2007 Action Plan.

North Dade Community Development Federal Credit Union – North Dade Community Marketing/Awareness (CMA) Job-Technical Assistance (\$200,000)

This funding is to provide economic development technical assistance and entrepreneurial business assistance, bookkeeping, and budgeting to seven small businesses at 18591 NW 27th Avenue.

Peninsula-Edison Plaza, LLC (\$200,000)

Funding is being recommended to address a gap in construction financing. This 80,700 square foot shopping center will accommodate an anchor tenant and several other regional and local businesses in the Liberty City area.

FY 2006 CDBG – Community Advisory Committee Allocations

Madison Square Project f/k/a South Miami Strip Mall Pre-Development Phase II (\$100,000)

These funds support the feasibility study, acquisition, design and construction of a strip mall that will create 5 jobs in the South Miami community.

Historic Hampton House Community Trust, Inc. (\$20,000)

Funding will support the ongoing development of a Multi-Purpose Center at this site.

Martin Luther King Economic Development Corporation (\$100,000)

Funding will support the following four businesses: Liberty Square, Lincoln Fields, Stevcar, and the Veterans Employment Services at \$20,000 each. The balance of \$20,000 will be used for the administrative overhead.

Naranja Princeton Community Development Organization (\$59,000)

Funding will support the creation of the activity Princeton Square Mall, which is a 30,000 square foot economic development project consisting of a neighborhood retail center located on the SE corner of US1 and SW 252 Street in unincorporated Miami-Dade County. The goal is to create 50 jobs in the Naranja Princeton community.

Leisure City /Naranja/ Princeton Community Advisory Committee (\$10,000)

The cancellation of Next Step CDC's SOHO South Business and Job Training Incubator Construction Project made this FY 2003 allocation available for recapture, and will be placed in the Leisure City/Naranja/Princeton NRSA CAC Reserve.


Melrose NRSA Neighborhood Community Advisory Committee (CAC) Reserve (\$100,000)

In FY 2005, the CAC allocated \$100,000 to Miami-Dade Empowerment Trust to carry out single family rehabilitation for eligible homeowners within the NRSA. The Empowerment Trust has not been able to utilize these funds, and at the CAC's request, the activity is being de-funded and funds are being placed in the Melrose NRSA CAC Reserve to be voted on by members of the committee for alternate eligible use in conjunction with recommendations for the FY 2007 Action Plan.

Attached is Exhibit 1 which indicates the respective proposed funding recommendations of the Community Advisory Committees, and Board of County Commissioner District funds from FY 2006, FY 2005 and FY 2004. This amendment will reallocate FY 2004-2006 CDBG funds to activities to accomplish community revitalization through urban renewal, economic development activities and capital improvement. Exhibit 2, which is also attached, includes a detail of all the recaptured funds under \$1,000.

At the Board of County Commissioners Meeting of January 25, 2007 Commissioner Souto requested that \$100,000 of General Funds be allocated to the Bay of Pigs Museum.
