RESOLUTION AUTHORIZING THE COUNTY MAYOR TO RECEIVE AND EXPEND FEDERAL FUNDS FROM THE UNITED STATES DEPARTMENT OF JUSTICE OFFICE OF VIOLENCE AGAINST WOMEN TO SUPPORT THE MIAMI-DADE POLICE DEPARTMENT; AND FURTHER AUTHORIZING THE COUNTY MAYOR OR HIS DESIGNEE TO RECEIVE AND EXPEND FUNDS AND EXECUTE SUCH CONTRACTS AND AMENDMENTS AS REQUIRED IF AWARDED.

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board approve the County Mayor or his designee to apply for, receive, and expend \$426,706 from the United States Department of Justice Office of Violence Against Women, in substantially the grant application attached hereto and made a part hereof; and authorizes the County Mayor or his designee to receive and expend grant funds, execute such contracts and agreements as required by grant guidelines or to further the purposes described in the funding request; following approval by the County Attorney's Office; to expend any and all monies received for the purposes described in the funding request; to apply for, receive and expend future additional funds should they become available through this grant program; to file and execute any necessary amendments to the application for and on behalf of Miami-Dade County, Florida; and to exercise amendments, modifications, renewal, cancellation and termination clauses of any contracts and agreements on behalf of Miami-Dade County, Florida.





SUBJECT: Resolution Authorizing Grant Application for Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program Partnership

Agenda Item No. 3(O)(18)(A)

Recommendation

It is recommended that the Board approve the attached resolution, authorizing the County Mayor's action in applying for, receiving, and expending federal funds for the Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program from the U.S. Department of Justice, Office of Violence Against Women to support the Miami-Dade Police Department (MDPD) Domestic Crimes Bureau in the amount of \$426,706. The grant period is from October 1, 2007 until September 30, 2010, and does not require any matching local or in-kind funds.

Scope

The grant will provide countywide services.

Fiscal Impact/Funding Source

This grant will provide \$426,706 in federal funds to implement the proposed project. The grant does not require any matching local or in-kind funds. The funding source is the U.S. Department of Justice, Office of Violence Against Women.

Track Record/Monitor

The grant will be between the U. S. Department of Justice and Miami-Dade County and will be assigned to the Miami-Dade Police Department for grant management.

Background

The grant project will provide enhanced training and services to address elder abuse, neglect, and exploitation, including domestic violence, dating violence, sexual assault, and stalking, involving victims who are 50 years of age and older. To plan, design and implement the project, a community partnership was formed via Memorandum of Understanding (MOU) that includes major stakeholders addressing domestic violence in this community including: Miami-Dade Police Department; State Attorney's Office; Florida Department of Children and Families; Victims Response Inc. (The Lodge); MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.); Domestic Violence and Sexual Assault Council of Greater Miami (DVSAC); and the Eleventh Judicial Circuit of Florida.

The Partnership will form a multi-disciplinary Training Team comprised of a representative from the MDPD Domestic Crimes Bureau; the State Attorney's Office; Florida Department of Children and Families' Adult Protective Services Program; Victims Response Inc. (The Lodge); and MUJER. The Training Team, along with two detectives and investigators from MDPD, three judges from the Eleventh Judicial Circuit, and two prosecutors from the State Attorney's Office, will participate in a variety of training, such as a Train-the-Trainer Workshop; Judicial Institute; and Prosecutorial Workshop. As part of this grant, local training will be provided to the 34 municipal police departments located in Miami-Dade County, reaching a minimum of 136 police detectives and investigators (two per agency). Also, the Training Team will train personnel from approximately 15 community agencies that provide domestic violence and sexual assault services throughout the county.



B. Abstract/Proposal Summary

Miami-Dade County Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program Partnership, was formed to apply for this grant from the U.S. Department of Justice, Office on Violence Against Women [OVW]. The Partnership has come together to plan, design, and implement the planned project to provide enhanced training and services to address elder abuse, neglect, and exploitation, including domestic violence, dating violence, sexual assault, and stalking, involving victims who are 50 years of age and older. Requested funding through this grant initiative is for \$426,706 for a three-year project period.

The Multi-Disciplinary Team [MDT] partnership comprising Miami-Dade County; State Attorney's Office; Florida Department of Children and Families; Victims Response Inc. [The Lodge]; MUJER [Mujeres Unidas en Justicia, Education y Reforma, Inc.]; Domestic Violence and Sexual Assault Council of Greater Miami; and the Eleventh Judicial Circuit of Florida; will attend the multiple training sessions, meetings and workshops required by the OVW.

Miami-Dade County as the lead applicant, shall be solely responsible for the expenditure and disbursement of grant funds, and shall assume all responsibility for managing all programmatic and fiscal records in accordance with the project reporting and auditing procedures required by this grant. The Multi-Disciplinary Team members, along with detectives and investigators, judges, and prosecutors will participate in the required 3-Day Orientation Meeting; 5-Day Train-the-Trainer Workshop; 4-Day Judicial Institute; 2.5-Day Prosecutorial Workshop; and 2-Day Project Wrap-up Session. Training associated with this grant opportunity will be provided to the 34-member municipal police departments located in Miami-Dade County, reaching 136 police detectives and investigators (two per agency). The MDT will train 15 community agency's staff through this grant initiative. The Project training and services, over the three-year period will impact the quality of services provided to victims of domestic violence and sexual assault, especially victims age 50 and over.

D. Purpose of Application

Statutory Purpose Area 1#:

Miami-Dade County, Florida does not currently provide training to assist law enforcement, prosecutors, and local courts in recognizing, addressing, investigating and prosecuting instances of elder abuse, neglect and exploitation including domestic violence, dating violence, sexual assault, or stalking against women who are 50 years of age or older. In October 2002, the Advocate Training and Treatment Program of Miami-Dade County held a training workshop to examine the issue of domestic violence, sexual assault, and abuse of older adults in Miami-Dade County. Participants unanimously agreed that staff and other resources for responding to victims in the Target Population in the county were poorly-coordinated, under-trained, and over-extended, and that the needs of these older victims are not being met. Moreover, participants believed that the Court and criminal justice responders failed to realize that victims in the Target Population are different from their younger counterparts. Since October 2002, several local organizations have developed small programs to begin to address the identified gaps. However, more comprehensive training and services are needed.

Law Enforcement: The county includes separate police departments for 34 municipalities plus the Miami-Dade Police Department [MDPD], which serves unincorporated county areas, and some cities via contract agreements. All departments provide training for new hires on domestic violence [DV], sexual assault [SA], stalking and abuse, and neglect and exploitation of

older victims and vulnerable adults protected by various Florida laws. These trainings include a basic understanding of the laws that protect these victims as well as model policies and procedures for effective response specific to the police department where the trainee will be employed. MDPD has its own training bureau, which trains recruits on a variety of topics including: vulnerable adults (8 hours), DV (20 hours), officer-involved DV (4 hours), plus additional training regarding child abuse and exploitation. A separate training module addresses state and federal laws as they pertain to SA. Miami Dade College trains recruits from the municipalities, using a curriculum that includes vulnerable adults (6 hours), and 44 additional hours that cover a variety of topics such as DV, SA, and child abuse. After law enforcement officers leave the academy, follow-up training is rare.

Prosecution: The State Attorney's Office has a specialized DV/SA prosecution unit for DV and SA cases. As with law enforcement, prosecutors do receive training in DV and SA but the training experience is limited because of frequent rotations and high caseloads and occurs with young prosecutors. There is no training on the issue of older female victims.

Judiciary: The Court is divided into Divisions, all of which are impacted by cases affecting the target population. The DV Division handles DV misdemeanor and civil injunction cases, the Probate Court sees cases involving vulnerable adults, and the Criminal Division handles DV felony and SA cases along with criminal cases of elder abuse. All judges receive judicial education in these various fields. However it is limited to a few days each year. Again, there is no training that addresses the target population.

Florida Department of Children and Families Adult Protective Services (APS): APS offers training programs for their investigators and case managers and for other community agencies upon request. By definition, however, their policies, procedures, and training curriculum only

focus on vulnerable adults which is a small segment of the target population. Again, high turnover neutralizes training efforts.

Local community training initiatives are limited to grant funds and are not sufficient to address the diverse training needs of the criminal justice partners. One such initiative, *Taking a Closer Look*, was funded by the National Institute of Justice's Violence Against Women Program. This project used a collaborative community team from the Miami-Dade State Attorney's Office, the Safespace Foundation, Inc., the ARC of South Florida, and the Center on Aging and Disabilities at the University of Miami to: (1) develop a model comprehensive training curriculum for justice professionals; (2) create a model victim needs screening tool for victim counselors to better support older victims and individuals with disabilities; and (3) create a model assessment tool for use in the Probate Court, to detect elder guardianship wards who are at high risk for abuse. Notably, this training only focused on vulnerable adults and not on the total Target Population.

Solution #1:

The grant partners will develop a Multi-Disciplinary Training Team [MDT] which will consist of one representative from the following MOU partners: Law Enforcement (Miami-Dade Police Department), the State Attorney's Office; Victim Response Inc, (The Lodge), a non-profit DV/SA victim service agency; MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.), a non-profit SA victim services agency; Florida Department of Children and Families, Adult Protective Services Program; and the Eleventh Judicial Circuit of Florida. The appropriate team members of the MDT will attend and participate in each of the required meetings, trainings, and workshops to be provided by OVW including: (1) 3-Day Orientation meeting; (2) 5-Day Train-the-Trainer session; (3) Advance Law Enforcement training; (4) 4-Day Judicial Institute; (5) 2.5-

Day Prosecutors Workshop; and (6) 2-Day Project Wrap-up meeting. In addition, the MDT will train 136 detectives and investigators from MDPD and 34 municipal police departments locally. The team will also train a compliment of five designated staff from each of the MOU partner entities. (See Project Trainings and Schedule document).

Statutory Purpose Area #3:

The county does not currently have a multi-disciplinary collaborative community response to victims in the target population. Researchers from The Center on Aging at Florida International University reported that many of the 134 participants (ages 45-81 and residents of the county) in their 2005 focus group study *Domestic Violence Against Older Women (DVAOW)*, funded by the National Institute of Justice, DVAOW participants identified “justice system response” as one of the most significant systemic barriers to *help-seeking* for older victims. Some respondents expressed fears about possible police brutality toward the abuser and many perceived that arrest, restraining orders, or court interventions did not help, and sometimes made things worse. Other issues included concern that police do not understand the situation and fear that police may ridicule an older domestic abuse victim. Most respondents were aware that help from the justice system was likely to be temporary and would only stop the immediate abuse without dealing with underlying problems or providing viable long-term alternatives. Nevertheless, DVAOW participants noted that the justice system was still the first place to turn and described ways the justice system in the county could be improved to better meet the needs of older victims, including marketing services to older people, helping victims with justice system processes, improving training, and placing police and court personnel who specialize in domestic abuse in neighborhood centers.

Solution #3:

The County has made some significant strides toward developing a coordinated community response (CCR) to victims in the target population. In 2003, the County commissioned a countywide needs assessment that would address gaps in system response and services to all adult victims of DV and SA. In February 2004, in response to that report, more than 45 criminal justice and community-based programs formed the Domestic Violence and Sexual Assault Council of Greater Miami [DVSAC]. However, the needs assessment did not specifically address the needs of victims in the target population; the DVSAC has a much broader focus.

Beginning January 2007, the DVSAC and eight of its member agencies, including the MDPD Domestic Crimes Bureau, the SAO, the public defender, the Eleventh Judicial Circuit of Florida, the Florida Department of Children and Families' local Adult Protection Services Unit [APS], the Miami-Dade County Domestic Violence Oversight Board, the Miami-Dade County Coalition to Prevent Abuse of Vulnerable Adults [CPAVA], and the local Area Agency on Aging, will participate on a Community Advisory Group as part of an NIJ-funded research project in Miami-Dade County conducted by The Center on Aging (NIJ# 2006-WG-BX-0008). Advisory Group activities will include review of research findings from survey research to be conducted in 2007, based on a 2005 qualitative study, that will identify specific barriers to *help-seeking* for the target population in Miami-Dade, information regarding successful CCR programs around the country in areas related to the target population, review and evaluation of existing policies and procedures with regard to older DV and SA victims in participating agencies, and development of a draft CCR plan for victims in the Target Population prior to mid-2009 project completion.

As specified in the attached MOU for this proposal, DVSAC members will collaborate with CPAVA members to develop a plan which will incorporate existing infrastructure and the

collective expertise of its members to target the needs of this population. The planning team will incorporate the infrastructure of the existing County funded one-stop centers, which includes MUJER, Women's Shelter of Hope, VRI, existing Miami-Dade County Domestic Violence Injunction Intake Centers, and the planned Domestic Violence Assistance Center [DVAC], to achieve multi-disciplinary collaborative community responses to older victims. The proposed one-stop Domestic Violence Assistance Center, scheduled for completion by December 2007, will co-locate the County's DV programs with law enforcement, the State Attorney's Office, and community-based DV and SA providers, which has been identified as a major service gap for DV and SA victims of all ages in the County.

It is expected that these activities, as described in the attached MOU, will co-occur with or follow-up on activities undertaken as part of the NIJ# 2006-WG-BX-0008 project's goal to develop a draft coordinated community response plan for addressing needs of the target population. Many of the key partners including DVSA and CPAVA will be active participants in both efforts. There is a natural symbiosis between the two projects. If this proposal is funded, it will leverage existing resources and NIJ research funding mentioned above by adding important training and implementation components, enhancing and accelerating the results of both projects for the community, and providing enriched feedback to OVW and other Department of Justice Departments regarding the target population. A Letter of Support from the funded project team is included in this proposal.

Statutory Purpose Area # 4

Cross-training for victim services organizations, governmental agencies, courts, law enforcement, and non-profit, non-governmental organizations serving victims in the target population does not occur. This training is needed to maintain necessary up-to-date expertise in critical agencies. Staff from criminal justice and community-based agencies serving the target population have limited opportunities to attend multi-disciplinary trainings with regard to these victims, often as a result of limited funds and training time. Consequently, these professionals never get an opportunity to learn from one another or to build capacity, and as a result, their services may be provided in a vacuum.

Solution #4

Each of the required trainings for APS, law enforcement, prosecutors, non-profit organizations, and the judiciary will be open to all of the partner agencies as well as community-based providers serving the needs of the target population. In this way, at minimal cost, each of the MDT trainings will potentially expand the knowledge of every allied professional. APS, DV, and SA service providers from 15 local agencies will be cross-trained by MDT with the local law enforcement. It is estimated that each agency will send at least 2 representatives to these trainings. In addition, we will hold one multi-disciplinary, countywide training/conference within the grant period. We estimate attendance of approximately 150 representatives from the combined agencies at the countywide training. All trainings will be widely publicized in the community through local chapters of relevant professional organizations, internet-based community updates, and community announcement sections of the major local newspapers, including the three leading newspapers to reach Creole, Spanish, and English speaking audiences.

Identify Target Population: The Target Population resides throughout the County. It is difficult to obtain an accurate picture of the numbers and needs of DV and SA victims over the age of 50 because not all agencies keep this data. DVAOW researchers said that older victims often face internal and external barriers that prevent them from seeking or accepting help. Not surprisingly, many researchers think the extent of elder mistreatment is much higher than reports of DV and elder abuse indicate (Collins et al., 1999¹; Pillemer & Finkelhor, 1988²; Tjaden & Thoennes, 2000³).

A recent survey of court, criminal justice, and social service agencies illustrates the need. In 2005, MDPD and local municipal police departments reported a total of 15,480 DV and SA offenses. Of these, 5,802 incidents [37%] were reported by MDPD. Of these 802 [14%] involved victims over the age of 50. An additional 1,040 cases involved older victims in dating relationships or other acquaintance or familial relationships that do not meet the DV statutory criteria. In addition, MDPD has an Elderly Exploitation Unit that investigates 100-150 incidents involving vulnerable adults each year.

In 2006, the State Attorney's Office filed 9,033 DV felony and misdemeanor cases. Of these, 502 cases [6%] involved victims age 50 and over. During that same period, 9,574 petitioners filed for protection orders. Of these, 602 petitioners [6%] were over the age of 50. During the same period, social service providers rendered services to 3,094 adult DV/SA

victims. Of those, approximately 292 [9%] were victims over age 50. Approximately 55% were Hispanic.

Florida Department of Children and Families Adult Protective Services [APS] is a state entity intended to protect vulnerable adults from being harmed, as specified in state statute (FS 415). These adults, who represent a portion of the target populations, may experience abuse, neglect, or exploitation by second parties or may fail to take care of themselves adequately. Florida statutes require any person who knows or who has reasonable cause to suspect any abuse of vulnerable adults to report that information to the Florida Abuse Hotline.

In 2005, there were 43,450 adult protective investigations. APS provided protective services to 9,293 disabled and elder adults. The problems are that APS is understaffed, and faces high turnover and burnout. Oftentimes it is difficult for non-professionals to articulate the problem to hotline staff in such a way as to convey the urgency and need. In these cases, no services are offered.

Current Services and Gaps: The Miami-Dade County (MDC) has supported numerous efforts to reduce Domestic Violence [DV] and Sexual Assault [SA]. The Court was one of the first jurisdictions in the nation to establish a DV criminal misdemeanor and civil injunction court with special dockets to monitor DV offenders. The MDC also funds protection order intake centers located at four geographically convenient courthouses. The SAO has a specialized DV crime unit. Most major police agencies have specialized DV and SA units. The MDPD has developed clearinghouses for DV and SA crimes whereby municipal police departments (33) can voluntarily post information. All police departments have policies and procedures regarding DV arrest, investigation, and enforcement of Injunctions. MDPD has a special unit dedicated that investigates crimes against older victims. The Community Corrections Agency has a specialized

DV unit that monitors compliance of DV offenders referred to certified batterer intervention programs. The County has funded two One-Stop Center's including MUJER, a grassroots community-based organization, in Deep South Miami-Dade [Deep South Dade], which provides coordinated services to the predominately Mexican migrant, farm worker community and three DV shelters, including The Lodge. The Lodge provides traditional shelter-based services including advocacy services for older victims of DV and SA. The MDC also has plans to open the first of three Domestic Violence Advocacy Centers [DVAC] by the end of 2007. The DVAC will co-locate County DV agencies with personnel from law enforcement and the State Attorney's office along with community based providers.

APS identifies vulnerable adults in need of services through the Abuse Hotline. The hotline screens these allegations to determine whether the information meets the criteria of an abuse report. Adult protective investigations are conducted for all abuse reports to determine whether there is evidence that abuse, neglect, or exploitation occurred; whether there is an immediate or long-term risk to the victim; and whether the victim needs additional services to safeguard his or her well-being. The program provides case management to clients who need additional services in order to be protected from further harm. Case management may be intensive, involving frequent contact with the victim (such as two or three visits a week), and typically lasts for three to six months. It may involve removing victims from an unsafe environment and relocating them to a setting where their needs can be safely and suitably met, such as a nursing home or an assisted living facility. In addition, the program may refer some clients to additional services to help ensure that they are not subject to further abuse.

As previously stated, law enforcement has no uniform training criteria or standard operating procedures that address police response with regard to these victims across departments; does not

have training programs to assist law enforcement, prosecutors, and local courts in recognizing, addressing, investigating and prosecuting instances of elder abuse, neglect and exploitation including domestic violence, dating violence, sexual assault, or stalking against victims who are 50 years of age or older; does not provide sufficient services for victims in the target population; and does not have centralized coordinated community services for victims in the target population.

Community Service Area Where the Project Will Be Implemented Including Location, Population and Demographic Information: The County is situated in the Southeast corner of Florida. The County spans approximately 2,000 square miles, and has a resident population of 2,363,600. The County is ranked third in the nation for its number of immigrants. Fifty-one percent report themselves to be foreign born. Sixty-eight percent report that English is not spoken at home. Though rich in cultural diversity, 1 in 4 falls below the federal poverty level. The overall median income is \$35,966. The senior-elder population for persons over age 50 is 678,353 (28.7%).

Particular Population to be Served by the Project: Law enforcement officers, judges, prosecutors, and service providers will benefit from training. The MDT will train an estimated 136 law enforcement detectives and investigators from 34 police departments. OVW will provide specialized required training as stipulated earlier. The MDT will train five staff from their respective organizations; APS, DV, and SA service providers from 15 local agencies will be cross-trained by MDT. It is estimated that each agency will send at least 2 representatives to these cross-trainings. The planned county-wide multidisciplinary training is expected to reach at least 150 representatives from the combined agencies.

How does the intended audience benefit from the training? There is no existing on-going training, educational or training materials that meet the current needs of the target population. There are sporadic trainings but they are not sufficient. If funded, law enforcement, State Attorney personnel, non-profit partners, APS, and judges will have the information that they need to address the target population as stated in Solution #1.

Enhancements to current DV and SA training programs: This program will enhance all existing law enforcement; State Attorney's Office; Court and service provider trainings that do not specifically address the target population.

E. What Will Be Done

The proposed project will provide previously unavailable training to local law enforcement, Adult Protective Services, community-based DV and SA organizations, State Attorney's Office, and the Judiciary. The Director of MDPD is the current elected President of the Dade County Association of Chiefs of Police. The Director, on behalf of this County grant application, will recommend that training associated with this grant opportunity be provided to the 34 member municipal police departments that comprise the association, in addition to MDPD personnel. This mandatory law enforcement training will comprise 16 hours over a four-day period, and reach a minimum of four personnel from each department (two detectives and two investigators) depending on the size of the agency. Trainings will be held at MDPD's Training Bureau facility, to allow for on-site delivery. Trainings will be staggered throughout the month to allow for scheduling of officers to attend the training. All local law enforcement trainings will be complete within 12 months of the adaptation of the national curriculum to local needs. MDPD will lead the project and will hire the Project Coordinator. General management of the project will be provided by MDPD and the County. Collaboration and support will be provided by the MOU

partners including senior level staff from the following entities: Miami-Dade County Departments (MDPD, Human Services, and Senior Advocate); and VRI, MUJER, APS, The State Attorney's Office, and the Court. MDPD and the County will work with their respective staffs to plan, implement, provide services and all trainings, monitor, prepare reports, and evaluate the project over the life of the grant. The MOU partners will hold their first meeting following funding, and will continue to meet throughout the life of the grant.

Following funding, the MOU partners will select the members for MDT who will attend the three day OVW orientation meeting and the five day national train-the-trainer conference. MDT members include one member from each of the following: MDPD, SAO, APS, and VRI/MUJER. In addition, two detectives and two investigators each from the Domestic Violence Bureau and the Sexual Crimes Bureau will attend the advanced OVW local law enforcement training. The SAO will also send two prosecutors to the mandatory 2.5 day workshop, which will focus on prosecution of elder abuse cases. The AOC will send 3 judges to the four-day judicial institute focusing on elder abuse, neglect and exploitation, and will invite the MDT to conduct training for court personnel and criminal justice professionals. The partners have agreed that VRI will represent both VRI and MUJER at the trainings. In turn, VRI will train MUJER staff. MUJER will assist with trainings in the law enforcement agencies in South Dade and will add its expertise to the local curriculum as to those issues that impact older immigrant victims. MDT members will train court staff through the Domestic Violence Court DV University, an "In-House Training Institute." Finally, a member of the NIJ# 2006-WG-BX-0008 research team will use travel funding from that project to attend and participate in the three day OVW orientation meeting and the five day national train the trainer conference to maximize consistency in efforts from both projects.

Importantly, cross-training of all providers and partners, both in terms of identifying victims and providing appropriate response and intervention, will be provided as outlined in the solution to Problem #4 below.

All partners will review their policies and procedures to create more effective police, court, prosecution policies, protocols and orders in DV and SA cases for purposes of identifying, investigating and prosecuting the cases involving the Target Population. This policy review period will occur simultaneously with the local trainings and will be complete in the third year of the grant.

DVSAC will enhance its goals to meet this statutory purpose. Over the grant period, DVSAC will use its committee structure and its diverse membership and expertise in DV and SA to create policies and procedures that will build capacity and expertise among its members to better meet the needs of older victims of DV and SA. DVSAC members in collaboration with the MOU partners and the Community Advisory Group as part of an NIJ-funded research project in Miami-Dade County will form an OVW Planning and Development Committee and develop a plan which will incorporate existing infrastructures and collective expertise of its members that will target the needs of this population. The Project Coordinator funded by this grant will staff this committee.

The Project Coordinator will plan and implement all multi-disciplinary trainings including the countywide training referenced in Solution #4 above. The Project Coordinator will determine which service providers are to be invited to the cross-trainings based upon the clients they serve.

F. Who Will Implement the Project?

General management of the project will be provided by MDPD and the County. MDPD will hire the Project Coordinator following funding of the project initiative. MOU partners

including senior level staff from the following entities: Miami-Dade County Departments (MDPD; Human Services, and Senior Advocate); VRI, MUJER, APS, The State Attorney's Office and the Court will provide collaboration and support. The MDPD and the County will work with their respective staffs to plan, implement, provide services and training, monitor, prepare reports, and evaluate the project over the life of the grant. The MOU Partners will hold its first meeting within the DVSAC structure following funding and will continue to meet throughout the life of the grant.

The County as the lead applicant, shall be solely responsible for the expenditure and disbursement of grant funds, and shall assume all responsibility for managing all programmatic and fiscal records in accordance with the project reporting and auditing procedures required by this grant. The County's Finance Department will handle the fiscal component of the grant with MDPD. The County has a vast resource network of Social Service Departments and Divisions that provide services to victims of domestic violence, sexual assault, abuse, neglect, and exploitation, numerous County Boards, Committees, and Task Forces to provide support, guidance, and advocacy on behalf of victims in Miami-Dade County. Key staff for MDPD will be Major Mike Herrera, Chief Domestic Crimes Bureau and Major Cindy Bucholtz, Chief Sex Crimes Bureau.

The MDPD, SAO, APS, and VRI will be responsible for: (1) sending representatives to OVW mandatory trainings and for providing cross trainings as identified above; (2) adapting the national curriculum to the local needs including the addition of relevant statutes; and (3) the review of policies and practices and implementation of new policies and put in place a body of policies and protocols, based on a multi-disciplinary collaboration, designed to aid in improving in the identification, investigation, prosecution, and adjudication in the target population.

MUJER will be responsible for the above with the exception of #1. The SAO will assign Carrie Soubal, Chief Administrator DV and SA and Esther Rubio, Esq., Chief Prosecutor DV and SA Crimes to the project. APS will assign Yinka Adeshina, Program Manager to the project. VRI will assign Angela Diaz-Vidiallet CEO to the project. MUJER will assign Susan Reyna, CEO, to the project. The additional MOU Partners will assign key staff to the DVSAC OVW Planning and Development Committee. Job Descriptions are provided for the two funded positions requested through this grant (Project Coordinator and Police Sergeant).

G. Sustainability

DVSAC will continue to provide an on-going forum for the partners to improve system response and coordination of services and service delivery for the victims of the target population. APS will continue to serve the needs of the vulnerable population. The SAO will continue to provide periodic training to its prosecutors regarding the effective prosecution of crimes against the target population. MDPD will include the training curriculum as part of their training to new recruits at the police academy. MUJER will continue to provide services and accept referrals of victims DV and SA in the target population south of Kendall Drive. VRI has a County funded program to coordinate services for referred individuals in the target population. Most referrals have come from MDPD and the County-run domestic violence protection order clinics. The Lodge staff who serve as Elder Advocates have been trained to work with elder victims using specialized assessments to identify specific needs of their clients. Over the past two years, the elder advocate provides intake, follow-up and case management services to 52 unduplicated cases, 20 of which occurred in 2006. The MOU Partners and the FIU Advisory Group will continue to collaborate to improve coordination of services to the target population.



THIS Memorandum of Understanding (the "MOU") is entered into as of the 7th day of February, 2007, by and between **MIAMI-DADE COUNTY**, a political subdivision of the State of Florida, whose address is 111 N.W. 1st Street, Miami, Florida 33128, Attention: County Manager (hereinafter the "County"); **STATE ATTORNEY'S OFFICE**, of the Eleventh Judicial Circuit, Miami-Dade County Florida, whose address is 1350 N.W. 12 Avenue, Miami, Florida 33136, Attention: State Attorney (hereinafter the "State Attorney"); **FLORIDA DEPARTMENT OF CHILDREN AND FAMILIES**, a State of Florida Department, for its **Adult Protective Services Program**, whose address is 401 N.W. 2nd Avenue, Miami, Florida 33128, Attention: District Administrator (hereinafter the "Adult Protective Services"); **VICTIMS RESPONSE INC. (THE LODGE)**, a not-profit domestic violence services program and shelter facility, whose address is 5040 NW 7th Street, Miami, Florida 33126, Attention: CEO (hereinafter "The Lodge"); **MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.)**, a nonprofit, one-stop domestic and sexual violence program, whose address is 28905 South Dixie Highway, Homestead, Florida 33090, Attention: Executive Director (hereinafter "MUJER"); **DOMESTIC VIOLENCE AND SEXUAL ASSAULT COUNCIL OF GREATER MIAMI**, a communitywide 45-member agency council, whose address is 5040 NW 7th Street, c/o Advocate Program Inc., Miami, Florida 33126, Attention: Chairperson (hereinafter the "DVSAC"); and the **ELEVENTH JUDICIAL CIRCUIT OF FLORIDA**, acting by and through the Administrative Office of the Courts, whose address is the Lawson E. Thomas Courthouse Center, 175 N.W. 1st Avenue, Miami, Florida 33128, Attention: Court Administrator (hereinafter the "Eleventh Judicial Circuit"); collectively known as **Miami-Dade County Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program Partnership** (hereinafter the "Partnership").

RECITALS

WHEREAS, the partnership has been formed as of February 7, 2007; and

WHEREAS, the Miami-Dade County Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program Partnership, comprising Miami-Dade County; State Attorney's Office, Florida Department of Children and Families, Victims Response Inc. (The Lodge), MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.), Domestic Violence and Sexual Assault Council of Greater Miami, and the Eleventh Judicial Circuit of Florida; have come together to make an application for the Enhanced Training and Services to End Violence and Abuse of Women Later in Life

Program, to provide enhanced training and services to address elder abuse, neglect, and exploitation, including domestic violence, dating violence, sexual assault, and stalking, involving victims who are 50 years of age and older; and

WHEREAS, the entities listed have agreed to enter into a Partnership and implement the Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program in Miami-Dade County, to provide enhanced training and services to address elder abuse, neglect, and exploitation, including domestic violence, dating violence, sexual assault, and stalking, involving victims who are 50 years of age and older; and

WHEREAS, the Partnership desires to enter into this MOU setting forth the services to be provided by the Partnership toward the planning, development and implementation of the Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program; and

WHEREAS, the application prepared and approved by the Partnership is to be submitted to the U.S. Department of Justice, Office on Violence Against Women (OVW) for the Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program; and

WHEREAS, this Partnership is contingent upon funding of the Miami-Dade County Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program application by the U.S. Department of Justice, Office on Violence Against Women (OVW); and

WHEREAS, this proposed Partnership and the terms and conditions of this MOU are also contingent upon ratification, consent, and approval by the Board of County Commissioners for the County; State Attorney for the State Attorney's Office; Legal Counsel for the Florida Department of Children and Families; Board of Directors for Victims Response Inc. (The Lodge); Board of Directors for MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.); Board of Directors for the Domestic Violence and Sexual Assault Council of Greater Miami, and the Legal Counsel for the Eleventh Judicial Circuit of Florida; and

WHEREAS, the partners have come together to plan, design, and implement the Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program, to provide enhanced training and services to address elder abuse, neglect, and exploitation, including domestic violence, dating violence, sexual assault, and stalking, involving victims who are 50 years of age and older; the following **Sections (I – XIV)** are inclusive of this MOU, and provide the framework for the services to be provided through this Partnership initiative; and

WHEREAS, the Partnership now wishes to enter into this MOU in order to set forth terms, conditions and services:

NOW, THEREFORE, in consideration of the Premises, and of the mutual covenants and agreements set forth below, the parties agree as follows:

Section I – History of Collaboration

1.1 History and Experience

The partners to this agreement have a long-standing history and experience of working in collaboration with local governments, the State of Florida, non-profit agencies, and other entities to provide programs, projects and services on behalf of victims of elder abuse, neglect, and exploitation, including domestic violence, dating violence, sexual assault, and stalking, in Miami-Dade County, Florida.

1.2 Miami-Dade County [MDC]

Miami-Dade County's Mission: Delivering excellent public services that address community needs and enhance the quality of life, serves as the focal point for all services to the county's 2,253,149 residents.

In 1992, the County and the Eleventh Judicial Circuit of Florida created the **Miami-Dade County Domestic Violence Coordinating Council** of the Eleventh Judicial Circuit of Florida. The Council served as a roundtable forum for effective communication and coordination between all integral court and community agencies involved with the Domestic Violence Division of the court. The community roundtable facilitated change and reform within the community, by bringing together police, judges, prosecutors, advocates, defense attorneys, court administration staff, treatment providers, the medical community, the legal community, educators, and others with access to families and victims of domestic violence.

The **Miami-Dade County Domestic Violence Oversight Board [DVOB]** was created to serve in an advisory and oversight capacity to the Miami-Dade County Board of County Commissioners on issues pertaining to domestic violence. Through, the DVOB, a plan was developed to use a portion of the local food and beverage sales tax proceeds to establish domestic violence in the County. Today, the DVOB works to generate and maximize federal and state funding for the County, while monitoring the provision of services to domestic violence victims.

The **Miami-Dade County Alliance for Human Services [A4HS]** was established by the Board of County Commissioners in 1999, to establish a coordinated social and human service planning process for MDC. The first Health and Social Services Master Plan was produced in 2001, and established. A primary goal for Domestic Violence, Rape and Sexual Assault included in the Plan was, and continues today, the promotion community awareness and education to prevent domestic violence, rape, and sexual assault in MDC, and to ensure access to, and availability of, culturally appropriate multidisciplinary service responses for victims and their families in high need geographic areas.

In 1993, the County assisted in the formation of the **Dade-County Alliance Against Domestic Violence**, a community-based organization created to increase the awareness of domestic violence and ensure victim safety through support, education and advocacy via community partnerships.

In 2007, MDC will establish a four regional **Domestic Violence Assistance Centers (DVAC)**, to enhance services at four regional courthouses where victims of domestic violence may obtain injunctions for protection orders against domestic violence. The

expanded services will promote victim safety, offender accountability, arrest, and enforcement of protection orders. The Centers will provide an array of services designed to impact violence against women among diverse and traditionally underserved populations. These enhanced services will include bi-lingual attorneys; representation for battered immigrant victims; community-based, faith-based, and shelter-based advocates; and case management and victim follow-up services.

Miami-Dade County's **Project Planning and Development Team** is comprised of senior level staff that have voluntarily come together to form the Partnership and the Multi-Disciplinary Training Team. They include staff from the following entities: Miami-Dade Office of Strategic Business Management, Revenue Maximization and Grants Coordination Division; Miami-Dade County Departments (Police, Human Services, and Senior Advocate); State Attorney's Office, Florida Department of Children and Families, Adult Protective Services Program; Victims Response Inc. (The Lodge); MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.); and the Eleventh Judicial Circuit of Florida, Administrative Office of the Court. The Planning and Development team members will work in tandem with their respective staff to plan, implement, provide services and training, monitor, prepare reports, and evaluate the project.

1.3 Miami-Dade County Police Department [MDPD], Domestic Crimes Bureau and Sexual Assault Bureau

The MDPD is the County's law enforcement agency, and as such, provides statutory policing countywide, and supports the 34 municipal police departments in Miami-Dade County. MDPD services and divisions in support of domestic violence and sexual assault include Domestic Crimes Bureau, Sexual Assault Bureau, Court Services, Crime Scene Bureau, Crime Laboratory, and Training Bureau.

The **Domestic Crimes Bureau** is responsible for the coordination of all Departmental activities related to family crimes, including but not limited to domestic violence, child exploitation, elderly/disabled adult abuse, and missing persons.

The **Sexual Crimes Bureau** is responsible for the coordination of all Departmental activities related to sexual crimes, including but not limited to investigation of sexual crimes and assaults; sexual predators and offender identification and registration; DNA compliance screening; Internet crimes; and participation in the National Sexual Crimes Clearinghouse.

Over the years, the MDPD has served as a collaborative partner in support, advisory, leadership, consultative, and advocacy roles, on numerous County and community boards, committees and task forces. Some include the Miami-Dade County Domestic Violence Coordinating Council; Miami-Dade County Domestic Violence Oversight Board (DVOB); Miami-Dade County Youth Crime Task Force; Miami-Dade County Alliance for Human Services (A4HS); and Miami-Dade County Alliance Against Domestic Violence.

1.4 Miami-Dade County Department of Human Services [DHS]

Miami-Dade County's Department of Human Services provides **Domestic Violence Services**, including crisis intervention and safe space shelters for victims and families of domestic crimes. Shelters include Safespace North, Safespace South, and the INN Transition program. Other DHS services include counseling, information and referral to other services, transportation, emergency financial assistance, emergency food and clothing, and advocacy and support.

DHS provides **Family and Victim Services**, which includes clinical treatment to offenders and victims of domestic violence. Treatment may be voluntary or court ordered. Services include information and referral; advocacy and support; psycho-social assessment; and individual and group therapy.

DHS program services provide collaborative support to the **Jackson Memorial Hospital Roxcy Bolton Rape Treatment Center**. Direct and indirect program services are provided to clients of the center through DHS's network of countywide service locations.

1.5 Miami-Dade County Office of the Senior Advocate

Miami-Dade County's Office of the Senior Advocate was established in 2006, to serve as an advocate for seniors residing in the County. The Senior Advocate serves as a County representative on community boards, committees, and task forces. As its mission, the Office is charged with supporting the interest of seniors and programs and services designed to improve their quality of life.

1.6 State Attorney's Office [SAO]

The Office of the State Attorney for the Eleventh Judicial Circuit of Florida has a well-established national record as a leader in the effort to end domestic violence. In 1986, when the Domestic Crimes Unit was established it was Florida's first specialized prosecution unit dedicated exclusively to the prosecution of domestic violence cases, and has become a model for other prosecutors' offices throughout the state and the nation.

The **Victim/Witness Assistance Program** of the State Attorney's Office is likewise an innovative unit that offers comprehensive services for victims and witnesses involved in the Criminal Justice System. The Office has been a leading advocate for the victims of crime since 1981, and the program serves almost 17,000 victims annually.

Among other Miami-Dade County State Attorney's Office initiatives are: (1) the **M.O.V.E.S. (Mobile Operations Victim Emergency Services) Program**, which takes paralegals/advocates specialists out into the community right after a domestic violence arrest after working hours and on weekends to serve the victims of domestic violence and to quickly initiate the activities of the legal system; (2) the **SAVE-NET (Serious About Violence Ending Network)** is a partnership with the private business sector to put cellular phones directly linked to the Emergency 911 system in the hands of high risk victims in order to facilitate the ability of the authorities to protect them from violence; and (3) the **VAN (Victim Access Network) Program** is an automated information system which will allow every crime victim to get updated information 24 hours a day on the progress/status of their case.

The SAO has a long history of collaborating with community partners including law enforcement, non-profit advocacy organizations, and recently with the Miami-Dade County Sexual Assault Response Team.

1.7 Florida Department of Children and Families [FDCF], Adult Protective Services Program

Florida has one of the most comprehensive and responsive adult abuse, neglect, and exploitation investigation systems in the nation. Many states have used Florida's legislation as a model for establishing Adult Protective Services programs. From mandatory reporting to 24-hour on-call investigators, the state has demonstrated its commitment to the detection and correction of abuse, neglect, and exploitation of vulnerable adults.

The **Adult Protective Services Program**, mandated by Chapter 415, Florida Statutes, is a system of specialized social services directed toward protecting vulnerable adults who are unable to manage their own affairs, from further occurrences of abuse, neglect, or exploitation. Assessment of an individual's need for protective services is initiated in response to a reported allegation of abuse, neglect, or exploitation. The four components of Adult Protective Services are: 1.) The on-site investigation of all reports of alleged abuse, neglect, or exploitation; 2.) Determination of immediate risk to the vulnerable adult and the provision of necessary emergency services; 3.) Evaluation of the need for and provision of on-going protective supervision; and 4.) Provision or arrangement of on-going protective services.

Protective Investigations include investigations of reports of abuse, neglect, or exploitation through observation, evidence gathering, and collateral contacts. **Protective Supervision** is the primary source of service delivery for those vulnerable adults who were determined through a protective investigation to be in danger of continued abuse, neglect, or exploitation. Services to protect the victim from further abuse, neglect, or exploitation may be provided or arranged by the protective supervision program.

FDCF has served as a resource clearinghouse for community-based agencies and local government by providing data, information and reports in the furtherance of services provided to senior/elder victims of abuse, neglect and violence in Miami-Dade County.

1.8 Victims Response Inc. (VRI) [The Lodge]

Victim Response, Inc./**The Lodge Domestic Violence Center (The Lodge)**, a non-profit corporation, is Miami-Dade County's newest domestic violence (DV) 40-bed shelter and is located in North Miami-Dade County. This program provides traditional shelter services including: Information and Referral, Counseling, Emergency Shelter, Hotline, Child Assessments, Case Management, Community Education, Professional Training, and Community Advocacy.

In addition, since July 1, 2004, the Lodge has offered a specialized program for older victims. The target population are elderly men and women who are victims of DV and sexual assault (SA) over the age of 50 whose cases fit the statutory definition of DV set forth in Section 741.28 FI Statutes, or elders whose cases fit the statutory definition of rape or sodomy set forth in Chapter 794 FI Statutes, and that do not meet the criteria for

inclusion under Section 741.28 FI Statutes. All frail Elders that fall under the protection of Florida Statutes Chapter 415 and the Florida Department of Children and Families are specifically excluded from the project.

In 2006, the Lodge entered into an agreement with **The Journey Institute** in Miami-Dade County, to provide mental health counseling for victims of sexual assault. The Journey Institute (TJI) is a division of Family Counseling Services of Greater Miami, a 501(c) 3 Not for Profit Corporation. TJI's therapists provide mental health counseling and individual therapy for victims of sexual assault, including adult survivors of incest and child incest victims. TJI clients have access to an expanded range of services including psychiatric services, case management, a family loan program and assistance with applying for Medicaid funding for healthcare.

In addition to the formal collaborations, VRI also receives referrals from: MDPD Domestic Battery Unit and Sexual Battery Unit, Fire Rescue, State Attorneys Office (Domestic Crimes Unit and Sexual Assault Unit) Domestic Intake unit of the Eleventh Judicial Circuit, DCF/Adult Services, Alliance for Aging, Inc, United Home Care Services, Jackson Memorial Hospital, Women's Hospital Center, the Veterans Administration Hospital, JMH Rape Treatment Center, Legal Aid, Hospitals, Community Mental Health Agencies and other service providers who serve victims of DV.

The program makes referrals and works in conjunction with: Legal Aid, Mailman Center, The Journey Institute, Douglas Gardens CMHC, Awakenings, Fellowship House, Residential Plaza, Jackson Memorial Hospital, LUCHA, Little Havana Activities and Nutrition Center, Victim Assistance Program, STS Transportation, Foster Grandparent Program, Day Treatment Center, Medically Needy program, DCF and other service providers.

1.9 MUJER [Mujeres Unidas en Justicia, Education y Reforma, Inc.]

In 2001, the County funded a One-Stop Center: MUJER, (Mujeres Unidas en Justicia Educacion y Reforma), a grassroots community-based organization, in Deep South Miami-Dade, which provides coordinated services to all victims who suffer from violence and abuse, but concentrate their efforts in serving Latino migrant farmworkers and immigrants.

MUJER is a non-profit corporation originally established by Latino farm workers in South Miami-Dade County to serve the needs of that migrant community. MUJER has proven successful in reaching families who do not access the system, and is recognized as a safe place for migrant farm worker women who are victims of violence. MUJER also provides community agencies with training and education on the plight of migrant farm workers. MUJER's range of programs includes a **One-Stop Domestic and Sexual Violence Program**, which provides comprehensive services to victims. In 2006, MUJER received provisional certification as a **Rape Crisis Center** from the Florida Council Against Sexual Violence. In 2007, a collaboration of ten (10) organizations will develop a Family Violence Service Partnership Network to create a seamless, coordinated response to domestic violence and sexual assault.

[2005] Sexual Assault Response Team Advocacy Partnership [SARTAP]

In December 2006, The Lodge entered into a Memorandum of Understanding with 13 other community based agencies including MUJER to provide follow-up services to victims of Sexual Assault. This partnership supports the Miami-Dade County Sexual Assault Response Team [SART] which includes Miami-Dade Police Department Sexual Battery Unit; MUJER and the State Attorney's Office. This agreement followed 18 months of meetings and discussion by the partners.

[2005] Grants to Encourage Arrest Memorandum of Understanding

In September 2006, Miami-Dade County was awarded a grant of \$800,000 as part of the Grants to Encourage Arrest Program. VRI, MDPD Domestic Crimes Bureau, MUJER and other partners entered into a collaboration to provide enhanced legal and advocacy services to victims seeking protection orders. This grant included enhancement of the MDPD's Domestic Violence Clearing House which tracks incidents of domestic violence across police jurisdictions. This collaboration occurred as a result of gaps in services identified by the DVSAC partners in 2003.

In January 2005, The Lodge entered into an agreement with MUJER in order to better coordinate and effectively manage the provision of services to MUJER clients and their dependants who are victims of domestic violence, rape, and sexual assault, who reside in deep South Dade County, who are seeking refuge at The Lodge.

In return, MUJER provided the following services to victims referred from the Lodge: case management; information and referral, counseling, advocacy and support services for adult and child witnesses. Both MUJER and The Lodge provide mutually beneficial cross training on a variety of service and program issues.

1.10 Domestic Violence and Sexual Assault Council of Greater Miami [DVSAC]

The Domestic Violence and Sexual Assault Council of Greater Miami (DVSAC) was formed in February 2004, in response to a recommendation of the *Miami-Dade County Domestic Violence Report and Assessment of Gaps in Services* (DV Report) report funded by the County. DVSAC provides a forum where criminal justice and community-based partners collaborate to develop a countywide coordinated community response to DV and sexual assault. DVSAC is comprised of 45 agencies including the Court, local government, criminal justice and community-based agencies. The membership includes the partners to this grant. The mission of DVSAC is improved services and system response for all victims of domestic violence and sexual assault. The DVSAC members have developed standing committees to accomplish its goals. DVSAC agrees to enhance its committee structure and to use its diverse membership and expertise to create policies and procedures that will build capacity among its members to better meet the needs of older victims of DV and SA. APS will appoint appropriate representatives to the DVSAC that are experts in the area of elder abuse, neglect and exploitation in order to assist this effort. The Committee will also work to add local information (statutes, resources, etc.) to the national curriculum, making it relative to the Miami-Dade County community.

This history of collaboration among the court, criminal justice partners and community based partners began in 1991 when the Court, Miami-Dade Police Department, the State Attorney's Office, the Public Defender's Office, the Advocate Program, Inc.,

[community corrections], the Miami-Dade Department of Human Services developed the *Miami-Dade County Domestic Violence Plan* which established the Domestic Violence Court; the Domestic Violence Intake Unit of the Court Administrator's Office; specialized DV units in law enforcement agencies and community corrections; expanded local DV shelters and the DV Crimes Unit of the State Attorney's Office. For the past 15 years, these partners have met as part of the Court's Standing Committee on DV in order to solve problems and improve the operations of the DV Court and related agency responses. Gradually, over time community-based partners began to emerge in the County, each with their own specialized response to victims.

Prior to formal creation of DVSAC in February 2004, the partners worked together for two years to identify gaps in local system and service response for victims. During that time, the partners provided data, answered surveys and participated in in-depth interviews. This process not only identified the gaps but led to recommendations for improved system response and service delivery. DVSAC members, including the partners to this grant, are responsible for the development of the Miami Dade County Sexual Assault Response Team (SART); Sexual Assault Response Team Advocacy Partnership (SARTAP); planning and development of the DVSAC website; Grants to Encourage Arrest application and resulting award; as well as advocacy on a variety of issues important to victims of domestic violence and sexual assault.

1.11 Eleventh Judicial Circuit of Florida, Administrative Office of the Court [AOC]

The Eleventh Judicial Circuit of Florida, serving Miami-Dade County, is the largest in the state and the fourth largest trial court in the nation. Its 123 Circuit and County Court judges serve a population of over two million in a 2,000 square mile area. Eighty judges preside in six Divisions of the Circuit Court and 43 judges preside in three Divisions of the County Court.

Since the early 1980's, the Eleventh Judicial Circuit has served as a collaborative partner in judicial, support, advisory, consultative, and advocacy roles, on numerous County and community boards, committees and task forces. Some include the Miami-Dade County Domestic Violence Coordinating Council; Miami-Dade County Domestic Violence Oversight Board (DVOB); Miami-Dade County Youth Crime Task Force; Miami-Dade County Alliance for Human Services (A4HS); and Miami-Dade County Alliance Against Domestic Violence.

Section II – Development of Application

2.1 In January, Miami-Dade County's Office of Strategic Business Management, Revenue maximization and Grants Coordination Division convened a meeting of County Departments, state representatives, and community-based organizations whose mission and services targeted victims of domestic violence, abuse, neglect, sexual assault, and elder victims. An agreed Partnership was formed for the purpose of applying for this DOJ – OVW grant opportunity. A working group comprising Miami-Dade County's grants staff; and representatives from the State Attorney's Office, Florida Department of Children and Families, Victims Response Inc. (The Lodge), MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.), Domestic Violence and Sexual Assault Council of Greater Miami (DVSAC), and the Eleventh Judicial Circuit of Florida; came together to plan,

conduct research, strategize, and prepare the grant application, project budget, MOU, and letters of commitment required for the application.

Subsequent grant writing and discussion working sessions over the month of January and early February were held to prepare and complete the application; and included discussions pertaining to the statutory program purposes of the grant; program activities; application requirements; establishing goals and objectives for the Partnership and the Multi-Disciplinary Team (see Letters of Commitment); and establishing partner responsibilities for participation in trainings, and the delivery of same to local law enforcement agencies. Each partner prepared and submitted a budget for the proposed staff trainings and activities to be funded under this application.

Section III – Roles, Responsibilities and Resources

NOW, THEREFORE, it is hereby agreed by and between the partners as follows:

3.1 Miami-Dade County [MDC]

Miami-Dade County as the lead applicant, shall be solely responsible for the expenditure and disbursement of grant funds, and shall assume all responsibility for managing all programmatic and fiscal records in accordance with the project reporting and auditing procedures required by this grant. The vast resources of the County will be used in support of this grant initiative, and will include the County's 311 Call Center, which is a phone help-line service provider to County residents and businesses. Calls are answered and information is provided in English, Spanish and Creole. The center operates 7 days a week, Monday - Friday from 6 am to 10 pm, and on Saturday and Sunday from 8 am to 8 pm, and 24-hours during emergency events such as hurricanes. Calls pertaining to alleged neglect, exploitation, domestic violence, dating violence, sexual assault, stalking, and elder abuse, are handled by trained staff, which refer callers to the appropriate County department, law enforcement agency, community-based organization, hospital, or appropriate entity for service.

The County has a network of Social Service Departments and Divisions that provide for a coordinated and comprehensive delivery of services to victims of domestic violence, sexual assault, abuse, neglect, and exploitation. Numerous County Boards, Committees, and Task Forces, exist to provide support, guidance, and advocacy on behalf of victims in Miami-Dade County.

3.2 Miami-Dade County Police Department [MDPD], Domestic Crimes Bureau and Sexual Assault Bureau

The Miami-Dade Police Department's Sexual and Domestic Crimes Bureau, Victim Services Section is committed to assisting victims of domestic violence and sexual crimes, and will facilitate services and serve as a liaison to community agencies and law enforcement.

The Bureaus will be responsible for assisting victims of domestic violence and sexual crimes 24 hours a day, 7 days a week. The goal is to provide a professional and

sensitive environment to victims while offering knowledgeable and current information about services and agencies available to assist victims.

The Bureaus will assist all victims regardless of sex, age, race, culture or disability. The Bureaus will work with a variety of agencies which will assist with translation and other services as necessary. The goal is to provide the most comprehensive and best quality of service to victims of domestic violence and sexual crimes.

Personnel/advocates from the Victim Services Section will assist the victim and their families with emotional support; explanation of the legal and investigative process; Crime Victims Compensation Forms; on-scene crisis intervention; referrals to mental health services, financial support programs, shelters, relocation services, and other miscellaneous agencies; and Follow-up assistance.

The State of Florida's Attorney General's Office provides guidelines for the fair treatment of victims, called the *Victim Bill of Rights*:

- A. The rights of sexual assault victims should be recognized, supported and enforced.
- B. Victims have the right to be treated with dignity, respect, understanding and empathy.
- C. Victims have the right to be free from threats, intimidation, coercion and harassment.
- D. Victims have the right to be kept informed on every step of the investigation and prosecution.
- E. Victims have the right to express a preference regarding prosecution.
- F. Victims have the right to be treated with impartiality.
- G. The safety and welfare of the victim should always be top priority.
- H. The victim has the right to prompt medical and/or psychological care.
- I. The victim has the right to request an investigator based on cultural, physical, language and gender issues.
- J. Victims have the right to privacy and confidentiality.
- K. Victims have the right to be informed about victim rights and services in the criminal justice system including victim compensation.
- L. Victims have the right to be heard and present in court proceedings.

In support of this grant initiative, MDPD will send one representative, at the rank of Captain, or above, to participate as a team member of the Miami-Dade County's Multi-Disciplinary Team, to the new grantee, three-day orientation meeting. The team member will represent MDPD's Domestic Violence Bureau and Sexual Crimes Bureau. The MDPD's Multi-Disciplinary Team member will attend the train-the-trainer national conference, and along with the other Miami-Dade County Multi-Disciplinary Team members, participate in the five-day training session.

The MDPD's Multi-Disciplinary Team member, along with detectives and investigators, will participate in the advanced law enforcement training, to be held locally. The Department will send the team member, two detectives and two investigators, each from the department's Domestic Violence Bureau and the Sexual Crimes Bureau.

The Director of MDPD is the current elected President of the Dade County Association of Chiefs of Police. The Director, on behalf of this County grant application, will recommend that training associated with this grant opportunity be provided to the 34-member municipal police departments that comprise the association, in addition to MDPD personnel. This mandatory law enforcement training will comprise 16 hours over a four-day period, and reach a minimum of four personnel from each department (two detectives and two investigators) totaling 136 participants.

MDPD will provide the resources of its Training Division in support of the local law enforcement training. The Division has extensive experience and capacity to deliver the training required by OVW.

MDPD agrees to fully participate in the evaluation of the program, and will send one team member to the 2-day Project Wrap-up Meeting.

3.3 Miami-Dade County Department of Human Services [DHS]

Domestic Violence Services will be provided by DHS including crisis intervention and safe-space shelters for victims and families of domestic crimes. Other services will include counseling, information and referral to other agencies and County departments, transportation, emergency financial assistance, emergency food and clothing, and advocacy and support.

3.4 Miami-Dade County Office of the Senior Advocate

The Office of the Senior Advocate will serve in an advocacy role in support of the Multi-Disciplinary Team and the Partnership's efforts to expand multi-disciplinary collaborative community responses to victims of elder abuse, neglect, and exploitation, including domestic violence, dating violence, sexual assault, and stalking, who are 50 years of age or older.

3.5 State Attorney's Office [SAO]

The State Attorney's Office recognizes the importance of stopping domestic violence and sexual assault. Staff is dedicated to assessing victim needs and supporting victims through the criminal justice process. The Sexual Abuse Unit and the Misdemeanor Domestic Violence Crime Unit handles felony sexual assault and felony and misdemeanor domestic violence crimes. Paralegals and Victim/Witness Counselors provide support to victims.

The felony and misdemeanor domestic violence units of the SAO handles *Walk-In Complaints* from any citizen who comes to the State Attorney's Office after a domestic violence incident where there has been no arrest. A paralegal will take sworn testimony regarding the incident, and a determination will be made after an investigation as to whether or not the SAO are able to go forth with criminal charges.

If *Arrested*, after an Arrest, parties will be notified to appear on a scheduled date and time to give sworn testimony regarding the incident. This is called the *Pre-Filing Conference*.

Our office has a long history of collaborating with community partners such as law enforcement, non-profit advocacy organizations and recently with the Miami Dade

County Sexual Assault Response Team. We are pleased to continue collaborating with our community partners and feel that this initiative to provide Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program is a positive step towards providing better service to these victims by providing training to our staff and the community.

In support of the grant initiative, the SAO will send two representatives (Prosecutors) to participate as a team members of the Miami-Dade County's Multi-Disciplinary Team, to the new grantee, three-day orientation meeting. The team members will represent the State Attorney's Sexual Abuse Unit and Misdemeanor Domestic Violence Units.

The SAO Multi-Disciplinary Team member, will attend the five-day train-the-trainer national conference, and along with the other Miami-Dade County Multi-Disciplinary Team members, participate in the five-day training session.

The SAO Multi-Disciplinary Team members (two Prosecutors) will participate in the mandatory 2-5 days workshop, which will focus on prosecution of elder abuse cases.

The two Prosecutors from the State Attorney's office, along with the Multi-Disciplinary Team members, will provide local training on elder victims of domestic violence and sexual assault to Prosecutors, Law Enforcement personnel, Paralegals, and Victim/Witness Counselors.

Resources provided by the SAO will include facilities for training for one of the training events with the understanding that training costs incurred will be provided by the grant budget. The SAO agrees to fully participate in the evaluation of the program, and will provide required programmatic and fiscal information to Miami-Dade County pertaining to grant funded activities. The SAO agrees to send one team member to the 2-day Project Wrap-up Meeting.

3.6 Florida Department of Children and Families [FDCF], Adult Protective Services Program (APS)

FDCF's Adult Protective Services Program will provide *Protective Investigations* by handling the investigation of reports of abuse, neglect, or exploitation through observation, evidence gathering, and collateral contacts, and referral from law enforcement, community agencies and health care facilities.

The APS program will provide *Protective Supervision* as the primary source of service delivery for those vulnerable adults who were determined through a protective investigation to be in danger of continued abuse, neglect, or exploitation. Services to protect the victim from further abuse, neglect, or exploitation may be provided or arranged by the protective supervision program.

The APS program will send one representative to participate as a team member of the Miami-Dade County's Multi-Disciplinary Team, to the new grantee, three-day orientation meeting. The team member will represent the State's Adult Protective Services Program.

The APS Multi-Disciplinary Team member, will attend the five-day train-the-trainer national conference, and along with the other Miami-Dade County Multi-Disciplinary Team Members, participate in the five-day training session.

The APS Multi-Disciplinary Team member will participate as a trainer in the advanced law enforcement training to be held locally. The APS agrees to fully participate in the evaluation of the program, and will provide required programmatic and fiscal information to Miami-Dade County pertaining to grant funded activities. The APS agrees to send one team member to the 2-day Project Wrap-up Meeting.

3.7 Victims Response Inc. (VRI) [The Lodge]

VRI will accept referrals countywide of older victims of domestic violence and sexual assault from law enforcement, the State Attorney's Office, the Court and other providers of targeted victims.

VRI will send one representative (Social Worker) to participate as a team member of the Miami-Dade County's Multi-Disciplinary Team, to the new grantee, three-day orientation meeting. Our Multi-Disciplinary Team member, will attend the five-day train-the-trainer national conference, and along with the other Miami-Dade County Multi-Disciplinary Team members, participate in the five-day training session. Further, VRI agrees to work as part of a training Team. VRI will work to add local information to the national curriculum, making it relevant to Miami-Dade County.

The VRI Multi-Disciplinary Team member will participate as a trainer in the advanced law enforcement training to be held locally.

VRI will engage in a review of its own policies and protocols and agrees to put in place a body of policies and protocols based on multi-disciplinary collaboration, designed to aid in improving in the identification of older victims of domestic violence and sexual assault.

VRI agrees to fully participate in the evaluation of the program, and will provide required programmatic and fiscal information to Miami-Dade County pertaining to grant funded activities. VRI agrees to send one team member to the 2-day Project Wrap-up Meeting.

3.8 MUJER [Mujeres Unidas en Justicia, Education y Reforma, Inc.]

MUJER will accept referrals of older victims of domestic violence and sexual assault from law enforcement, the State Attorneys Office, the Court and other providers of targeted victims residing in South Miami-Dade County.

MUJER will engage in a review of its own policies and protocols and agrees to put in place a body of policies and protocols based on multi-disciplinary collaboration, designed to aid in improving in the identification of older victims of domestic violence and sexual assault.

The MUJER agrees to fully participate in the evaluation of the program, and will provide required programmatic and fiscal information to Miami-Dade County pertaining to grant funded activities. The MUJER agrees to send one team member to the 2-day Project Wrap-up Meeting.

MUJER agrees to fully participate in the evaluation of the program, and will provide required programmatic and fiscal information to Miami-Dade County pertaining to grant funded activities.

3.9 Domestic Violence and Sexual Assault Council of Greater Miami [DVSAC]

DVSAC will provide a forum for the partners to this grant, Miami-Dade County; State Attorney's Office; Florida Department of Children and Families; Victims Response Inc. (The Lodge); MUJER (Mujeres Unidas en Justicia, Education y Reforma, Inc.); the Eleventh Judicial Circuit of Florida; and other relevant criminal justice, state and community-based agencies, the opportunity to develop and support an improved system response and delivery of services for victims of domestic violence, dating violence, sexual assault or stalking of victims 50 years of age and older. DVSAC members in collaboration with CPAVA members (*Coalition for the Prevention and Abuse of Vulnerable Adults*) will develop a plan which will incorporate existing infrastructures and collective expertise of its members that will target the needs of this population. The planning team will incorporate the infrastructure of the existing county funded one stop centers, which includes MUJER, Women's Shelter of Hope, VRI, existing Miami-Dade County Domestic Violence Injunction Intake Centers and the planned Domestic Violence Assistance Center [DVAC] to achieve a multidisciplinary collaborative community responses to the older victims.

3.10 Eleventh Judicial Circuit of Florida, Administrative Office of the Court [AOC]

Three Divisions of the Eleventh Judicial Circuit Court of Florida will send one Judge each to participate in the four-day judicial institute focusing on elder abuse, neglect, and exploitation. These Divisions are:

The **Family Division**, in which family matters concerning dissolutions of marriage, child custody and support, adoptions, paternity, modification proceedings, name changes, UREFAS, and domestic violence permanent injunction cases where there is an open family court action are heard; the **Probate Division**, in which probate matters such as the processing of wills and the settling of estates, as well as guardianship and mental health cases are heard; and the **Domestic Violence Division**, in which criminal domestic violence-related misdemeanors and injunction violation cases, as well as civil orders of protection (temporary and permanent domestic and repeat violence injunctions) are heard.

The AOC is strongly committed to this partnership on behalf of enhancing services to elder victims of violence and abuse in Miami-Dade County and, thus, commit to send 3 judges to the four-day judicial institute focusing on elder abuse, neglect and exploitation, and to invite the Multi-Disciplinary Training Team to conduct training for court personnel and criminal justice professionals.

The AOC will provide a forum for Multi-Disciplinary Team members, who have completed the five-day train-the-trainer national conference, to present at the Domestic Violence Court DV University, "*An In-House Training Institute.*"

AOC agrees to fully participate in the evaluation of the program, and will provide required programmatic and fiscal information to Miami-Dade County pertaining to grant funded activities.

Section IV – Term of the MOU

4.1 The term of this MOU shall commence on the last date of execution by the parties and continue for a 36-month period activity period, with the project end date to be determined and set by the U.S. Department of Justice, Office on Violence Against Women (OVW), unless terminated by any party pursuant to Section VIII below.

4.2 The parties agree that time is of the essence in the performance of each and every obligation under this MOU.

4.3 The parties agree to share in the proceeds of the grant dollars based on the determined scope of services, training requirements and project work/tasks, for the project grant request amount of \$426,706, as approved herein.

Section V – Project Management and Notice

5.1 The Project Manager for the County is the *Project Coordinator* and the *Multi-Disciplinary Team Member*, to be designated by Miami-Dade Police Department. *Multi-Disciplinary Team Members* will be designated for each required Partner entity: State Attorney's Office; Florida Department of Children and Families; Victims Response Inc. (The Lodge); and the Eleventh Judicial Circuit of Florida. The parties shall direct all matters arising in connection with the performance of this MOU, other than notices, to the attention of the Project Coordinator for attempted resolution or action. The Project Coordinator shall be responsible for overall coordination and oversight relating to the performance of this MOU.

Section VI– Indemnification

6.1 The County assumes any and all risks of personal injury, bodily injury and property damage attributable to the negligent acts or omissions of the County and the

officers, employees, servants, and agents thereof. The County warrants and represents that it is self-funded for liability insurance, or has liability insurance, both public and property, with such protection being applicable to the County officers, employees, servants and agents while acting within the scope of their employment with the County.

6.2 The State Attorney assumes any and all risks of personal injury, bodily injury and property damage attributable to the negligent acts or omissions of the State Attorney and the officers, employees, servants, and agents thereof. (The Lodge) or its employees, agents, servants, partners, principals or subcontractors. Victims Response, Inc. (The Lodge) shall pay all claims and losses in connection therewith and shall investigate and defend all claims, suits or actions of any kind or nature in the name of the County, State Attorney, Florida Department of Children and Families, and Eleventh Judicial Circuit of Florida, where applicable, including appellate proceedings, and shall pay all costs, judgments, and attorney's fees which may issue thereon. The Florida Department of Children and Families and the Eleventh Judicial Circuit of Florida shall maintain a fiscally sound and prudent risk management program with regard to their obligations under this MOU in accordance with the provisions of Section 768.28, Florida Statutes.

7.4 The parties hereto acknowledge that Victims Response, Inc. (The Lodge), and MUJER, (Mujeres Unidas en Justicia Educacion y Reforma) are non-profit corporations operating in the state of Florida, and are insured in accordance with provision as set forth by their Boards of Directors and By-laws. Victims Response, Inc. (The Lodge), and MUJER, (Mujeres Unidas en Justicia Educacion y Reforma) shall maintain a fiscally sound and prudent risk management program with regard to their obligations under this MOU in accordance with standard accounting provisions and practices as set forth by the American Accounting Association, and the provisions of Section 768.28, Florida Statutes.

Section VIII – Termination/Remedies

8.1 The County and the Florida Department of Children and Families may terminate this agreement in the event the application for the Enhanced Training and Services to End Violence and Abuse of Women Later in Life Program is not funded by the U.S. Department of Justice, Office on Violence Against Women (OVW). Any such termination shall be effected by delivery to the other of a Notice of Termination specifying the extent to which performance of work under the MOU is terminated, and the date upon which such termination becomes effective.

8.2 In the event a dispute arises which the Project Coordinator and Partnership members cannot resolve between themselves, the parties shall have the option to submit to nonbinding mediation. The mediator or mediators shall be impartial, shall be selected by parties, and the cost of the mediation shall be borne equally by the parties. The mediation process shall be confidential to the extent permitted by law.

8.3 This MOU has no third-party beneficiaries (intended or incidental), who may enforce obligations of any party should the MOU be terminated.

Section IX – Records Retention/Ownership

The County shall maintain records and each party shall have inspection and audit rights as follows:

9.1 Maintenance of Records: All parties shall maintain all financial and non-financial records and reports directly or indirectly related to the negotiation or performance of this MOU including supporting documentation for any service rates, expenses, research or reports. Such records shall be maintained and made available for inspection for a period of five (5) years from the expiration or termination date of this MOU.

9.2 Examination of Records: All parties or their designated agents shall have the right to examine in accordance with generally accepted governmental auditing standards all records directly or indirectly related to this MOU. Such examination may be only within five years from the expiration or termination of this MOU and upon reasonable notice, time and place.

9.3 Extended Availability of Records for Legal Disputes: In the event that any party should become involved in a legal dispute with a third party arising from performance under this MOU, the other parties shall extend the period of maintenance for all records relating to this MOU until the final disposition of the legal dispute, and all such records shall be made readily available.

9.4 Exemption: Any and all information not subject to disclosure under federal law, including but not limited to any and all criminal intelligence any and all criminal investigative information, any and all law enforcement relation information obtained, retained or created by the County, Florida Department of Children and Families, and the State Attorney is exempt from the requirements of this Article and is outside the scope of this MOU. The FDCF is exempt from providing confidential abuse and/or reporter information.

Section X – Standards of Compliance

10.1 The County, the State Attorney, the Florida Department of Children and Families, the Eleventh Judicial Circuit of Florida, Victims Response, Inc. (The Lodge), and MUJER, (Mujeres Unidas en Justicia Educacion y Reforma), their employees, subcontractors, partners or assigns, shall comply with all applicable federal, state, and local laws and regulations relating to the performance of this MOU to which their activities are subject.

10.2 The County, the State Attorney, Florida Department of Children and Families, the Eleventh Judicial Circuit of Florida, Victims Response, Inc. (The Lodge), and MUJER, (Mujeres Unidas en Justicia Educacion y Reforma), shall allow public access to all project documents and materials it maintains in accordance with the provisions of Chapter 119, Florida Statutes. Should the County assert any exemptions to the requirements of Chapter 119 and related statutes, the burden of establishing such

exemption, by way of injunctive or other relief as provided by law, shall be upon the County.

10.3 All parties assure that no person shall be excluded on the grounds of race, color, creed, national origin, handicap, age, sex, marital status, or sexual preference, from participation in, denied the benefits of, or be otherwise subjected to discrimination in any activity under this MOU. All parties shall take all measures necessary to effectuate these assurances.

Section XI – Relationship Between the Parties

11.1 The County, the State Attorney, the Florida Department of Children and Families, the Eleventh Judicial Circuit of Florida, Victims Response, Inc. (The Lodge), and MUJER, (Mujeres Unidas en Justicia Educacion y Reforma), are independent contractors. No party is an employee or agent of any other party. Nothing in this MOU shall be interpreted to establish any relationship other than that of independent contractors, between the County, State Attorney, the Florida Department of Children and Families, the Eleventh Judicial Circuit of Florida, Victims Response, Inc. (The Lodge), and MUJER, (Mujeres Unidas en Justicia Educacion y Reforma), or between their respective employees, agents, subcontractors, partners, or assigns, during or after the performance of this MOU.

Section XII – General Provisions

12.1 Notwithstanding any provisions of this MOU to the contrary, the parties shall not be held liable for any failure or delay in the performance of this MOU that arises from fires, floods, strikes, embargoes, acts of the public enemy, unusually severe weather, outbreak of war, restraint of Government, riots, civil commotion, force majeure, acts of God, or for any other cause of same character which is unavoidable through the exercise of due care and beyond the control of the parties. Failure to perform shall be excused during the continuance of such circumstances, but this MOU shall otherwise remain in effect.

12.2 In the event any provisions of this MOU shall conflict, or appear to conflict, the MOU, including all exhibits, attachments and all other documents specifically incorporated by reference, shall be interpreted as a whole to resolve any inconsistency.

12.3 Failures or waivers to insist on strict performance of any covenant, condition, or provision of this MOU by the parties, their successors and assigns shall not be deemed a waiver of any rights or remedies, nor shall it relieve the other parties from performing any subsequent obligations strictly in accordance with the term of this MOU. No waiver shall be effective unless in writing and signed by the party against whom enforcement is sought. Such waiver shall be limited to provisions of this MOU specifically referred to therein and shall not be deemed a waiver of any other provision. No waiver shall constitute a continuing waiver unless the writing states otherwise.

12.4 Should any term or provision of this MOU be held, to any extent invalid or unenforceable, as against any person, entity or circumstance during the term hereof, by force of any statute, law, or ruling of any forum of competent jurisdiction, such invalidity shall not effect any other term or provision of this MOU, to the extent that the MOU shall remain operable, enforceable and in full force and effect to the extent permitted by law.

12.5 This MOU may be amended only with the written approval of the parties hereto.

12.6 This MOU states the entire understanding and agreement between the parties and supersedes any and all written or oral representations, statements, negotiations, or agreements previously existing between the parties with respect to the subject matter of this MOU. The parties recognize that any representations, statements or negotiations made by the staff of either party does not suffice to legally bind either party in a contractual relationship unless they have been reduced to writing and signed by their authorized representative(s). This MOU shall inure to the benefit of and shall be binding upon the parties, their respective assigns, and successors in interest.

Section XIII – No Conflicts of Interest

13.1 The State Attorney, the Florida Department of Children and Families, the Eleventh Judicial Circuit of Florida, Victims Response, Inc. (The Lodge), and MUJER, (Mujeres Unidas en Justicia Educacion y Reforma), regarding conflicts of interest, shall certify that to the County, that no individual member of the Partnership, no employee, no subcontractor, and no subconsultant under this MOU nor any immediate family member of any of the same is also a member of any board, commission, or agency of the County. The Partnership hereby represents and warrants to the County that throughout the term of this MOU, the Partnership, its employees, its subcontractors, and its sub-consultants will abide by this Conflict of Interest prohibition.

Section XIV – Counterparts and Signatures


14.1 This Agreement may be executed in four (4) or more counterparts, each of which shall constitute an original but all of which, when taken together, shall constitute one and the same agreement.

The MDPD believes that this grant initiative will enable members of the Department, especially its detectives and investigators, to better serve the needs of elder victims of violence and abuse. The proposed training will enhance the department's current domestic violence and sexual assault training by providing personnel with an "evidence-based approach," by applying "best practices" to address the needs of victims of violence and abuse aged 50 and beyond. The mandatory law enforcement training will comprise 16 hours over a four day period, and reach law enforcement professionals in this Department in our Domestic Crimes Bureau and Sexual Crimes Bureau.

In addition, the training will be proposed to the Dade County Association of Chiefs of Police at the next regularly scheduled meeting. This would allow the critical training to be provided to the personnel of the 34-member municipal police departments that comprise the association. There is the potential that the training would reach, at a minimum, an additional 136 participants (two detectives and two investigators from each of the 34 member agencies).

Through the training provided under this grant funded initiative, it is possible that the entire community of law enforcement professionals will be trained. This will result in enhanced services county-wide and a coordinated law enforcement response to elder violence and abuse throughout our community.


The Probate Division, in which probate matters such as the processing of wills and the settling of estates, as well as guardianship and mental health cases are heard.

Project Coordinator
