

It is requested that the RCAC waive this Request To Initiate and Advertise onto the April 24<sup>th</sup> BCC Agenda due to the following exigent circumstances: The design grant requires the submittal of a construction contract by August 31, 2007, in order to claim an \$81,513 reimbursement for this project from the Florida Inland Navigation District (FIND). Not meeting the design reimbursement deadline may negatively impact the department's construction grant application with the aforementioned granting agency. The total amount of the grant application is \$1,127,500. The Expedite Ordinance 00-104 was in place during the planning phase of this project and as such was the schedule being followed by staff. The expedite ordinance is no longer in effect and staff feels that approval of this item would put Parks in a better position to ensure receipt of the Grant funding.



This grant expires 9-06. The project was completed and reimbursement was requested on time. Under the grant agreement we are required to submit a construction contract within one year of the grant termination (9-1-07). Can we get an extension of the time to present the construction contract? We have had a change in County government which results in all construction matters having to go to the County Commissioners before contracts can be awarded. This adds several months to the bid and award process. Of course, this was not contemplated in the original project schedule.

We are requesting a construction grant for this building this year. Permits are expected on time to comply with the requirements of the construction grant, if awarded.
