RESOLUTION NO. R-380-07

RESOLUTION CODESIGNATING SW 142ND
AVENUE FROM CORAL WAY TO BIRD ROAD AS
LISARDO RODRIGUEZ-CID AVENUE

WHEREAS, this Board has conducted a public hearing to consider codesignating SW 142nd Avenue from Coral Way to Bird Road as Lisardo Rodriguez-Cid Avenue; and

WHEREAS, Lisardo Rodriguez-Cid was born in Guantanamo, Cuba on January 11, 1927; and

WHEREAS, Lisardo Rodriguez-Cid immigrated penniless to the United States in the late sixties, formed a successful business in Puerto Rico, sold it and came to Miami in the mid 80s where he decided to develop single-family homes on investment property purchased in the 70s; and

WHEREAS, Lisardo Rodriguez-Cid enjoyed seeing neighborhoods develop with homes and their occupants; he felt that Miami was a city in transition and feared that dense zoning would lead to urban blight as had occurred in the northeast urban core; and

WHEREAS, Lisardo Rodriguez-Cid, inspired by native Floridians, felt the need to speak out on behalf of the residents of Miami-Dade County against irresponsible development. Lisardo believed that careless urbanization would inflict irreparable damages to the quality of life of the residents of Miami-Dade County. The love and respect he displayed for his newfound homeland is an admirable attribute that served as an inspiration to all that knew him; and

WHEREAS, Lisardo Rodriguez-Cid founded Concerned Citizens of West Dade in 1995, a group dedicated to maintain and improve the quality of life in West Miami Dade. Mr. Rodriguez-Cid successfully petitioned Miami-Dade County to prohibit blasting in developments and worked with developers to ensure that their projects would be beneficial to both sides, earning the respect and trust not only of his colleagues but also of those that did not agree with him; and

WHEREAS, Lisardo Rodriguez-Cid passed away on August 19, 2006; and

WHEREAS, this Board would like to honor the memory of Lisardo Rodriguez-Cid with this codesignation; and

WHEREAS, this proposed codesignation is located in County Commission District 11,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board approves the codesignation of SW 142nd Avenue from Coral Way to Bird Road as Lisardo Rodriguez-Cid Avenue.

Section 2. The Clerk of the Board is hereby directed to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.


