RESOLUTION APPROVING THE PLAT OF A WALK IN THE FALLS PARK, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 21, TOWNSHIP 55 SOUTH, RANGE 40 EAST (SW 148 STREET AND SW 93 COURT)

**WHEREAS**, Galloway Homes at the Falls, Inc., a Florida corporation, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as A WALK IN THE FALLS PARK, the same being a subdivision of a portion of land lying and being in the Southwest 1/4 of Section 21, Township 55 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.



A WALK IN THE FALLS PARK (T-22240)

- Located in Section 21, Township 55 South, Range 40 East

## PLAT RESTRICTIONS

- That the Streets, Court and Avenue, as shown on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems, and/or air conditioners.

- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- The utility easements at the sides, front and/or rear of certain lots, shown by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

**DEVELOPER'S OBLIGATION**

- Paving, street name signs, drainage, traffic control signs, striping and monuments. Bonded under bond number 7665 for the amount of \$162,063.00.
