RESOLUTION ADDING APPROXIMATELY 10 ACRES TO THE ENVIRONMENTALLY ENDANGERED LANDS (EEL) SOUTH DADE WETLANDS PROJECT AND TO THE EEL PRIORITY A ACQUISITION LIST AND AUTHORIZING THE COUNTY MANAGER TO PURSUE ACQUISITION OF PROJECTS ON THE EEL ACQUISITION LIST

WHEREAS, this Board desires to accomplish the purposes of Section 24-50 of the Code of Miami-Dade County, and to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby approves the addition of the 10 acres of folio 30-8801-000-0100, as shown in Attachment B, to the South Dade Wetlands Project and to the Environmentally Endangered Lands (EEL) Priority A Acquisition List, shown in Attachment A, and authorizes the County Manager to proceed with appraisals, environmental assessments, and other activities as necessary to pursue the acquisition of the projects on the Acquisition List, to negotiate for the acquisition of each project in its entirety, or for any portion thereof that would further the purposes for which the Environmentally Endangered Lands Program was established, and to present any and all purchase contracts which are negotiated pursuant to this resolution to the Board of County Commissioners for final approval.

**Subject:** Resolution Adding Approximately 10 Acres to the South Dade Wetlands Project and Environmentally Endangered Lands (EEL) Priority A Acquisition List

## Recommendation

It is recommended that the Board adopt the attached resolution which authorizes the addition of approximately 10 acres to the Environmentally Endangered Lands (EEL) Program's South Dade Wetlands Project and to the EEL Priority A Acquisition List (see Attachment A). This resolution is based on the recommendation made by the Land Acquisition Selection Committee (LASC) following their March 8, 2007 public hearing.

## Scope

This 10-acre property is a small addition to the 31,000 acre South Dade Wetlands Project which the County Commission placed on the EEL Priority A Acquisition List in 1993. To date, the County, in partnership with the South Florida Water Management District, has acquired approximately 16,000 acres within the South Dade Wetlands Project. Total EEL acquisitions to date exceed 18,000 acres.

## Fiscal Impact/Funding Source

Purchase of the subject 10 acres will be negotiated as part of a 25-acre purchase. The South Florida Water Management District (District) has obtained a \$70,000 grant to acquire the subject 10-acre property. Building Better Communities General Obligation Bond funding or the EEL Acquisition Trust Fund will be used to complete the entire purchase.

## Background

The subject 10-acre parcel is part of a 25-acre folio (30-8801-000-0100). The folio consists of two non-contiguous parcels: 15 acres lie within the South Dade Wetlands boundary and 10 acres lie outside the boundary (see Attachment B). The owner is willing to sell the entire folio. It is likely that the subject property was simply overlooked when the original boundary for the South Dade Wetlands was determined because one criterion for the original boundary was that the boundary not divide parcels or folios.

The subject parcel contains good quality graminoid or grassy prairie. The 15 acres located inside the project boundary are surrounded by EEL and District land. The 10-acre addition abuts District land on the south and County land on the east. Continued private ownership of this folio is an impediment to land management in the area.


