

Background


BACKGROUND: The NW 17 Avenue Bascule Bridge exhibits severe deterioration due to its age and surrounding corrosive environment. This deterioration has reduced the load carrying capacity of the bridge to a point where signs have been placed on the bridge to limit the weight of the vehicles using the bridge. Large emergency vehicles can now cross the bridge only under strict limitations. Excessive bouncing movements and vibrations of the bridge leaves occur due to the inadequacy of the existing locking mechanisms. The Florida Department of Transportation (FDOT) sufficiency rating is 18.4; any rating under 50, (out of 100), is grounds for bridge rehabilitation. PWD experienced delays in securing funding for the project and the outside permitting process was considerably long. However, the Department has been able to secure funding for this project and the outside permitting has been completed. Therefore, to prevent future structural failures, the Department requests approval of this RTA.
