RESOLUTION AMENDING RESOLUTION R-159-07  
DIRECTING THE COUNTY MANAGER TO  
PROMINENTLY DISPLAY ALL CO-DESIGNATION  
ROAD SIGNS ON AVAILABLE TRAFFIC CONTROL  
LIGHT MAST ARMS TO ADD DISPLAYING CO-  
DESIGNATIONS ON STREET SIGNS

**WHEREAS**, the County Manager has been directed by Resolution No. R-159-07 to prominently display co-designation road signs on existing traffic light mast arms; and

**WHEREAS**, signs co-designating roads in Miami-Dade County honor outstanding individuals who have made significant contributions to the community; and

**WHEREAS**, signs co-designating roads in Miami-Dade County should be visibly and prominently displayed along the entire portion of the road so co-designated,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that Resolution No. R-159-07 is hereby amended to include the prominent display of co-designated road signs on existing street signs.


