RESOLUTION NO. R#632-07

RESOLUTION URGING THE GOVERNOR OR SENATE PRESIDENT AND HOUSE SPEAKER TO EXPAND THE CALL OF THE SPECIAL SESSION SCHEDULED FOR JUNE 12, 2007 TO INCLUDE A TEMPORARY REDUCTION IN STATE MOTOR FUEL TAXES FOR A PERIOD OF THREE MONTHS PROVIDED SUCH LEGISLATION ENSURES THAT THE REDUCTION PASSES THROUGH TO CONSUMERS; FURTHER URGING THE FLORIDA LEGISLATURE, THE FLORIDA ATTORNEY GENERAL, THE COMMISSIONER OF AGRICULTURE AND CONSUMER SERVICES, AND OTHER PUBLIC OFFICIALS TO INVESTIGATE GASOLINE PRICING IN FLORIDA, AND PROVIDE A REPORT TO THE CITIZENS OF FLORIDA ON THE PROBLEM OF CONTINUING INCREASES IN THE PRICE OF GASOLINE AND POSSIBLE SOLUTIONS

WHEREAS, this gasoline price surpasses the August 11, 2006 record by 4.28 cents; and

WHEREAS, this price is only six cents shy of the all-time inflation-adjusted record price in March, 1981 when the price of regular gasoline was \$1.35 a gallon, which would be \$3.13 in today's dollars; and

WHEREAS, this summer's increasing gasoline prices largely have been attributed to the fact that no new refineries have been built in the U.S. in the last 30 years; and

WHEREAS, the 149 refineries that are currently in production have operated at or near 100 percent capacity for months in an effort to satisfy record consumer demand; and

WHEREAS, refineries operating at or near 100 percent capacity has produced a summer of fires, accidents and shutdowns, all of which have further limited refinery capacity and driven prices higher; and

WHEREAS, rising gasoline prices affect everyone on a daily basis, and consumers are in need of immediate relief from rising gasoline prices; and

WHEREAS, federal, state and local governments can all assist in providing needed relief to rising gasoline prices by temporarily reducing motor fuel taxes,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Governor or Senate President and House Speaker to expand the call of the special session scheduled for June 12, 2007 to include a temporary reduction in state motor fuel taxes for a period of three months, provided such legislation ensures that the reduction in state motor fuel taxes is passed through to the consumers, or similar legislation.

Section 2. Urges the Florida Legislature to pass legislation during the special session or otherwise that would temporarily reduce state motor fuel taxes by 50 percent for a period of three months provided such legislation ensures that the reduction in state motor fuel taxes is passed through to the consumers, or similar legislation.

Section 3. Urges the Florida Legislature, the Florida Attorney General, the Commissioner of Agriculture and Consumer Services, and other public officials to investigate gasoline pricing in Florida, and provide a report to the citizens of Florida on the problem of continuing increases in the price of gasoline and possible solutions.

Section 4. Directs the Clerk of the Board to transmit certified copies of the resolution to the Governor, the Attorney General, the Commissioner of Agriculture and Consumer Services, the Senate President, the House Speaker, and the chair and members of the Miami-Dade State Legislative Delegation.

Section 5. Directs the County's state lobbyists to advocate for the actions set forth in Sections 1, 2 and 3 and directs the Office of Intergovernmental Affairs to include this item in the 2007 and 2008 State Legislative Packages.

The foregoing resolution was sponsored by Commissioner Joe A. Martinez and Senator Javier D. Souto and offered by Commissioner Joe Martinez, who moved its adoption. The motion was seconded by Commissioner Jose "Pepe" Diaz and upon being put to a vote, the vote was as follows:


