**RESOLUTION DIRECTING THE COUNTY MANAGER TO  
PREPARE A PLAN FOR THE ENFORCEMENT OF CRIMINAL  
LAWS IN AND AROUND PUBLIC HOUSING PROPERTIES  
FOR THE BENEFIT OF PUBLIC HOUSING RESIDENTS AND  
THE PUBLIC**

**WHEREAS**, Miami-Dade County operates many Public Housing properties for the benefit of all residents of Miami-Dade County; and

**WHEREAS**, on occasion, residents of Public Housing, have been the victims of crimes in a greater number than many non residents; and

**WHEREAS**, the safety of Public Housing residents, employees and visitors to Public Housing is of utmost importance to this County; and

**WHEREAS**, the safety of citizens near and surrounding Public Housing is also of utmost importance to this County; and

**WHEREAS**, the strong enforcement of criminal laws in and around Public Housing is in the best interest of all residents of Miami-Dade County; and

**WHEREAS**, deterring crime in and around Public Housing is in the public interest and improves the quality of life for all residents of Miami-Dade County,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board of County Commissioners directs the County Manager to prepare a plan for the strong and consistent enforcement of criminal laws in and around the various Public Housing properties owned by Miami-Dade County for the protection of all citizens. The plan should include the feasibility and

cost of implementing a Public Housing Police Unit, as has been done in the past. The plan shall be returned to this Board of County Commissioners within 45 days of this date.






