RESOLUTION NO. R-1015-07

RESOLUTION NAMING THE COUNTY'S EXISTING GUARDRAIL PROGRAM THE "SHAYRA CASTRO GUARDRAIL PROGRAM" AND DIRECTING THE COUNTY MANAGER TO PREPARE A REPORT REGARDING THE FEASIBILITY, ADVISABILITY AND COST OF INSTALLING ADDITIONAL GUARDRAILS ON COUNTY ROADS RUNNING ALONGSIDE CANALS AND OTHER WATERWAYS

**WHEREAS**, some highways and roads in Miami-Dade County run parallel to canals and other waterways; and

**WHEREAS**, tragic accidents have occurred when drivers run off highways and roads and enter these waterways; and

**WHEREAS**, one such accident involved Shayra Castro who was a twenty-one year old woman who was loved by all who knew her; and

**WHEREAS**, Shayra Castro tragically passed away when, while traveling along a road without guardrails, her car went into a canal; and

**WHEREAS**, the County currently has a Guardrail Program which has resulted in the installation of approximately nine (9) miles of guardrails alongside County roads; and

**WHEREAS**, the County has yet to install guardrails alongside other County roads that run parallel to canals and other waterways; and

**WHEREAS**, the installation of guardrails on County roads running parallel to canals and other waterways may prevent vehicles from driving into such bodies of water; and

**WHEREAS**, the benefits of guardrails particularly along heavily-traveled highways and roads outweigh the cost of installation; and

**WHEREAS**, the County Commission further finds that the County's Guardrail Program should be named in honor of Shayra Castro,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that the County's existing Guardrail Program shall be named the "Shayra Castro Guardrail Program." The County Manager is directed to prepare a report regarding the feasibility, advisability and cost of installing additional guardrails on County roads running alongside canals and other waterways. The County Manager's report shall be submitted to the County Commission within ninety (90) days from the date of adoption of this resolution.

The foregoing resolution was sponsored by Commissioner Rebeca Sosa and offered by Commissioner Rebeca Sosa, who moved its adoption. The motion was seconded by Commissioner Joe A. Martinez and upon being put to a vote, the vote was as follows:




