WHEREAS, Liliana Isaza and Antonio Quintero, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Tract 4-C of "Little River Terrace", according to the plat thereof, as recorded in Plat Book 35, at Page 50, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 11, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


