RESOLUTION NO. R 998-07

**RESOLUTION DIRECTING THE COUNTY MANAGER TO
CREATE A PROGRAM FOR CORPORATE SPONSORSHIP
AND UNDERWRITING OF COUNTY PARKS**

WHEREAS, the Florida Legislature recently passed property tax reform legislation that will have the effect of substantially reducing the funds local governments have available for programs and services; and

WHEREAS, resulting budget cuts are likely to impact programs such as parks and libraries the hardest in order to minimize cuts to public safety programs such as police and fire; and

WHEREAS, local governments will need to be creative in finding ways to fund park and library programs during these austere budget times; and

WHEREAS, the State of Washington has come up with an innovative way to fund parks by crafting a policy that allows private sponsorship of public parks; and

WHEREAS, under the program, corporate sponsors underwrite construction and maintenance of park facilities and receive a plaque or other similar acknowledgement for their sponsorship; and

WHEREAS, this Board by Resolution No.1254-04 dated October 19, 2004 directed the County Manager to establish an Adopt-A-Park program and to provide quarterly reports on the status of the program; and

WHEREAS, the Adopt-A-Park program was intended to reach neighborhood associations, civic groups and neighborhood businesses and provide a mechanism for making small monetary and in-kind donations to be earmarked for specific neighborhood parks; and

WHEREAS, a program to seek corporate sponsorship for Miami-Dade County Parks could complement the Adopt-A-Park program and help fund park construction, maintenance and programs on a broad scale as budget reductions are made,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Manager to create a program for corporate sponsorship and underwriting of County parks; and to report back to this Board within ninety (90) days.

The foregoing resolution was sponsored by Commissioner Joe A. Martinez and offered by Commissioner **Jose "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Joe A. Martinez** and upon being put to a vote, the vote was as follows:


