RESOLUTION EXPRESSING SYMPATHY TO THE
RELATIVES AND FRIENDS OF THE VICTIMS OF FLIGHT
3054 WHICH CRASHED IN SAO PAULO, BRAZIL AND
OFFERING ASSISTANCE AND SUPPORT

WHEREAS, the citizens of Miami-Dade County were saddened by the horrific plane crash that occurred on July 18, 2007 at Sao Paulo's Congonhas airport in Brazil; and

WHEREAS, TAM Flight 3054 burst into flames and killed at least 189 people making it Brazil's worst air disaster; and

WHEREAS, this Board desires to provide assistance and support to Brazil in the form of medical assistance to burn victims, disaster search and recovery, forensic identification assistance and technical advice and support from the Miami-Dade Aviation Department,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board, on behalf of the citizens of Miami-Dade County, expresses its deepest sorrow and sympathy to the family and friends of the victims of the crash of Flight 3054 at Sao Paulo's Congonhas airport on July 18, 2007.

Section 2. This Board offers assistance and support to Brazil in the form of medical assistance to burn victims, disaster search and recovery, forensic identification assistance and technical advice and support from the Miami-Dade Aviation Department. This resolution and offer shall be immediately transmitted to the Governor of Sao Paulo, Brazil and the President of Brazil.






