RESOLUTION AUTHORIZING THE COUNTY MANAGER TO AMEND THE FY 2007 ACTION PLAN TO REFLECT THE REALLOCATION OF FY 1997, FY 1999, FY 2001, FY 2002, FY 2004, FY 2005, FY 2006 AND FY 2007 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS, IN THE AMOUNT OF \$15,334,100.99 AS INDICATED IN EXHIBITS I, II, III, AND IV; AUTHORIZING THE COUNTY MANAGER TO EXECUTE ALL CONTRACTS, AGREEMENTS AND AMENDMENTS NECESSARY TO CARRY OUT THE ABOVE PROGRAM; AND AUTHORIZING THE COUNTY MANAGER TO EXERCISE THE CANCELLATION PROVISIONS CONTAINED THEREIN.

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the County Manager to amend the FY 2007 Action Plan to reflect the reallocation of \$15,334,100.99 of FY 1997, FY 1999, FY 2001, FY 2002, FY 2004, FY 2005, FY 2006 and FY 2007 Community Development Block Grant Funds, as indicated in Exhibits I and II and authorizes the County Manager to execute such contracts, agreements and amendments, as are required, following approval by the County Attorney's Office and subject to proper execution by the parties; and to exercise the cancellation provisions contained therein.



*The item includes amendments from the June 19, 2007 meeting of the Economic Development and Human Services (EDHS) Committee meeting, and the July 10, 2007 meeting of the Board of County Commissioners. Attachment 1 to this cover memorandum details all of the amendments from both EDHS Committee and the Board of County Commission meeting.*

## RECOMMENDATION

It is recommended that the Board of County Commissioners (BCC) authorize the County Manager to amend the FY 2007 Action Plan to recapture unexpended funds from current and prior year projects and reallocate \$15,334,100.99 of FY 1997, FY 1999, FY 2001, FY 2002, FY 2004, FY 2005, FY 2006 and FY 2007 Community Development Block Grant (CDBG) Funds, as indicated in the attached Exhibits I and II. This total amount includes an additional \$876,104 provided by the U.S. Department of Housing and Urban Development (US HUD) as part of the FY 2007 entitlement.

## SCOPE

CDBG funds are being recaptured and earmarked to impact project management and completion of affordable housing, capital improvement, and economic development projects throughout Miami-Dade County Neighborhood Revitalization Strategy Areas. These funds will also be used to provide project management to ensure timely project completion. Exhibit 1 includes information on the Commission District for each project; however, the benefit of certain projects may affect more than one Commission District. In some cases, the benefit may be countywide.

## FISCAL IMPACT

Approval of this resolution does not create a negative fiscal impact to the County. A total of \$15,334,100.99 in multi-year CDBG funds are recommended for recapture from activities which 1) could not be carried out, 2) are completed and have unexpended balances, or 3) have expired contracts. The recaptured funds have been earmarked for use to complete affordable housing, capital improvement and economic development projects throughout Miami-Dade County Neighborhood Revitalization Strategy Areas (NSRAs). These funds will also be used to provide project management to ensure timely project completion.

The reprogramming of funds to activities that achieve their intended goals and objectives within certain timeframes reduces the County's risk of having CDBG funds deobligated by the federal government.

## **BACKGROUND**

The BCC approved the FY 2007 Action Plan on January 25, 2007 through Resolution R-43-07. Throughout the year, funded activities were tracked for compliance and funds from completed activities or those activities that are no longer feasible have been identified for recapture and recommended for reallocation to meet the needs of on-going initiatives. In addition, staff recommends that the recaptures and the funding adjustments be reflected in the FY 2007 Action Plan to ensure compliance with the U.S. HUD's spending ratio for the FY 2007 entitlement year.

The sources of recaptured and reallocated CDBG funds by activity type is detailed below:

### ***Public Service Funds – \$8,100,699.56***

The Public Service amounts identified for recapture in Exhibit 1 is comprised of the following:

- **\$2,404,392.76** represents the amount returned to the County's Line of Credit by U.S. HUD, to refund disallowed public service activities in 2005.
- **\$5,696,306.80** represents activities with unexpended balances or activities with balances that have been paid by County general funds and therefore do not require additional CDBG funds.

The Public Service amounts identified for reallocation are further detailed in Exhibit 1, but below is a general description of the allocations:

- **\$6,900,702.56** is the amount to County departments for homeownership mortgage assistance (Housing Finance Authority), public housing modernization (Miami-Dade Housing Agency), and for the land acquisition of a future housing development (Office of Community and Economic Development).
- **\$1,200,000** is to provide the City of Opa-Locka monies to completely fund the Curtis Drive Phase II Drainage System project.

### ***Non-Public Service Funds – \$2,783,401.43***

The Non-Public Service recaptures include activities that have been completed and remain with unexpended balances, or are no longer feasible because of capacity. A full listing of agencies with recaptured amounts is in Exhibit II.

The Non-Public Service reallocations in this category are comprised of the City of Miami Beach's Highland Village Sewer Improvements project (\$150,000); OCED for project support, the Commercial Revitalization Program (CRP), and land acquisition for a future affordable housing development (\$2,633,401.43).

### ***Community Advisory Council Funds – \$1,410,000***

The Community Advisory Council (CAC) recaptures (\$1,410,000) are from unexpended balances of activities awarded by CAC's from their annual allocation of \$100,000 over multiple years, as listed in Exhibit III.

The Community Advisory Council (CAC) reallocations are to various activities listed in Exhibit III. In summary, these allocations include the City of Opa-Locka for improvements to Segal Park (\$100,000), 2

OCED for various activities (\$810,000), Community Action Agency for the Elderly Residential Energy Conservation Program (\$100,000), the Madison Square Economic Development project (\$100,000), the Sunny Haven project (\$100,000), the Martin Luther King Economic Development Corporation for the business incubator and technical assistance (\$80,000), and At the Radius Group, Inc's rental rehabilitation of a five-unit project (\$20,000). An allocation was made on July 10, 2007 from the Perrine NSRA CAC Reserve Fund in the amount of \$100,000 for Neighbors and Neighbors Association to provide economic development technical assistance.

**Commission District Funds – \$3,040,000**

The recaptures from each Commission District Reserve (CDR) Fund are from FY 2007 and prior year unexpended balances in the CDR Fund. These balances are not being recaptured, but are in fact being allocated from the CDR Fund to activities identified by each Commissioner. The un-allocated balance of \$300,000 has been set-aside for future allocation by the respective Commissioner. The list of activities receiving reallocated CDR Funds is included in Exhibit IV.

**TRACK RECORD/MONITORING**

Most of the entities being recommended for the reallocation of CDBG funding have successfully delivered the products and/or services per their contractual agreements with OCED. Others are in the process of completing their projects and the additional funds in this item will assist in meeting their objective in a timely manner. The only agency receiving CDBG funding for the first time is At the Radius Group, Inc.

OCED through its planners, contracts officers, and project managers will work to monitor and manage the projects mentioned above to ensure successful completion and compliance with Federal guidelines and County policies.



## Attachment 1

### June 19, 2007 EDHS Committee amendments include:

- 1) \$100,000 from the Leisure City/Naranja/Princeton CAC Reserve Fund to the Naranja Princeton CDC Sunny Haven Water and Sewer Improvement project (reducing the \$810,000 allocation for land acquisition to \$710,000).
- 2) \$200,000 from the Commission District 8 Reserve Fund to the Housing Finance Authority for mortgage assistance to residents in Commission Districts 8 and 9.
- 3) \$200,000 from the Commission District 10 Reserve Fund to the Housing Finance Authority for mortgage assistance to residents in District 10.
- 4) \$20,000 from the Commission District 12 Reserve Fund to Hialeah-Dade Development for economic development projects.
- 5) \$180,000 from the Commission District 12 Reserve Fund to the City of Sweetwater Mildred Pepper Senior Center extension.
- 6) The item was also corrected to reflect that the "At The Radius Group, Inc" rental rehabilitation project is in Commission District 3.

### July 10, 2007 Board of County Commission amendments include:

- 1) \$200,000 from the FY 2007 Commission District 5 Reserve Fund to the Model Housing Cooperative, Inc. for the Villas Godoy Housing Project.
- 2) \$100,000 from the FY 2007 Commission District 1 Reserve Fund to the City of Opalocka Sherbondy Park rehabilitation Phase II and \$100,000 to the Segal Park Rehabilitation Park Improvements Phase I.
- 3) \$100,000 from the FY 2007 Perrine CAC to Neighbors and Neighbors for technical assistance to businesses within the Perrine NRSA area. This allocation will reduce the amount available for the OCED Land Acquisition/ Housing Initiative from \$710,000 to \$610,000.
- 4) \$105,000 from the FY 2005 Commission District 3 Reserve Fund to fund the South Florida Puerto Rican Chamber of Commerce for the Micro Lending Pilot program (\$40,000), Our Child Care Facility d/b/a Our Little Ones for child care facility improvements (\$30,000), Neighbors and Neighbors to provide technical assistance Economic Development projects (\$25,000), and the Contractors Resource Center to provide technical assistance to Economic Development projects (\$10,000).
- 5) The Board also directed the 1.5 million allocation to the Miami Dade Housing Finance Authority reflect that the funds available for individuals applying for first-time homebuyers mortgage(s) should be buyers from County funded projects.
