RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE TRANSIT AGENCY FOR THE JUNE 8-10, 2007 IT'S YOUR LIFE YOUTH CAMP SPONSORED BY EDUCATE TOMORROW CORPORATION, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$368.50 TO BE FUNDED FROM THE DISTRICT 4 IN-KIND RESERVE FUND

**WHEREAS**, the Educate Tomorrow Corporation has requested in-kind services from the Miami-Dade Transit Agency for the June 8-10, 2007 It's Your Life Youth Camp in an amount not to exceed \$368.50 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the It's Your Life Youth Camp is to teach and foster life skills for adolescences aging out of the foster care system; and

**WHEREAS**, the Educate Tomorrow Corporation is a not-for-profit organization; and

**WHEREAS**, the It's Your Life Camp is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the District 4 In-kind Reserve Fund,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board retroactively authorizes in-kind services from the Miami-Dade Transit Agency for the June 8-10, 2007 It's Your Life Youth Camp in an amount not to exceed \$368.50 to be funded from the District 4 In-kind Reserve Fund.





***Proposed Activities:***

**Interactive social activities:** Ropes Course, Business/Etiquette Luncheon, dinner/dance, movies, role playing skits, meeting with mentors. All social activities will include lessons on young adulthood and proper etiquette in communication and social interactions.

***Workshops:***

**Education curriculum** includes educational planning with hands-on use of the day planner to record important dates and timelines, personal goal setting, and a meeting with financial aid advisors and recruiters from local colleges and universities.

**Employment curriculum** includes; resume writing skills and strategies, the "do's" and "don'ts" of interviewing, and a mock job interview.

**Housing curriculum** includes guidance on finding housing through the Miami Herald classified, landlord/tenant lease review with emphasis on tenant responsibilities, security deposits, rent, habitable conditions, requests to repair, and other information.

**Consumer Skills curriculum** includes a comprehensive guide, developed by Mr. Elias, on car sales, consumer credit, false advertising, and price gouging.

**Health and Nutrition curriculum** includes evaluation of diet, preparation of food techniques with hands on experience and an overview of making the best choices to maintain proper health. Sessions with teen parents will include nutrition for parents and their children.

**Frequency, Intensity, and Duration:**

Five 3 day weekend trainings in the summer of 2007

***Number of Participants:***

250 eligible young adults from dependency, delinquency, CINS FINS, Casa Valentina and Kinship Care

***Number of Contacts per Participant:***
