## Recommendation

It is recommended that the Board approve the attached resolution authorizing the County Mayor or his designee to apply for up to \$200,000 in grant funds from the Florida Department of Environmental Protection, Florida Recreation Development and Assistance Program (FRDAP) for construction improvements at the Homestead Bayfront Atoll Pool, and to receive and expend funds and execute contracts and amendments as required.

## Scope

The Homestead Bayfront Atoll Pool is located at 9698 SW 328<sup>th</sup> Street, in Commission District 9.

## Fiscal Impact/Funding Source

The proposed grant project is estimated to cost \$923,000. The grant would contribute \$200,000 to the project, the remaining balance of \$723,000 will be provided from the Safe Neighborhood Parks Bond Program.

## Track Record/Monitor

The Park and Recreation Department (PRD) currently has two active FRDAP grants: \$200,000 for a pool and campground project at Larry and Penny Thompson Campground and \$200,000 for a ball field and field house project at Ives Estates Park. If awarded, the new grant will be administered by PRD Grants Administrator, Joyce Denny.

## Background

FRDAP is a competitive grant program that provides financial assistance to local governments for development or acquisition of land for public outdoor recreational purposes. All county governments and municipalities in Florida and other legally constituted local governmental entities with the legal responsibility for the provision of outdoor recreational sites and facilities for the use and benefit of the public are eligible. The maximum grant request may not exceed \$200,000.

Funding for this program is dependant on an annual appropriation of the Florida Legislature. The grant application is due September 13, 2007. Grant funds will be available July 2008.

RESOLUTION AUTHORIZING THE COUNTY MAYOR OR HIS DESIGNEE TO APPLY FOR UP TO \$200,000 IN GRANT FUNDS FROM THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION, FLORIDA RECREATION DEVELOPMENT AND ASSISTANCE PROGRAM FOR IMPROVEMENTS AT HOMESTEAD BAYFRONT ATOLL POOL AND FURTHER AUTHORIZING THE COUNTY MAYOR OR HIS DESIGNEE TO RECEIVE AND EXPEND FUNDS, AND EXECUTE CONTRACTS AND AMENDMENTS AS REQUIRED

**WHEREAS**, this Board desires to accomplish the purpose outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board authorizes the County Mayor or his designee to apply for up to \$200,000 in grant funds from the Florida Department of Environmental Protection, Florida Recreation Development and Assistance Program for improvements at Homestead Bayfront Atoll Pool; and further authorizes the County Mayor or his designee to execute such contracts and amendments as are required by this governmental body following approval by the County Attorney's Office; to receive and expend all monies for the purposes described in the funding request; file and execute any necessary amendments to the agreement for and on behalf of Miami-Dade County, Florida.
