RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT AND MIAMI-DADE POLICE DEPARTMENT FOR THE SEPTEMBER 16, 2007 CULTURAL INTEGRATION DAY EVENT SPONSORED BY THE COMMUNITY PERFORMING ARTS ASSOCIATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$5,555.00 TO BE FUNDED FROM THE DISTRICT 10 IN-KIND RESERVE FUND

**WHEREAS**, the Community Performing Arts Association, Inc., has requested in-kind services from the Miami-Dade Park and Recreation Department and Miami-Dade Police Department for the September 16, 2007 Cultural Integration Day event in an amount not to exceed \$5,555.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the Cultural Integration Day event is to conserve various cultures, enhance traditions, provide education awareness and cultural integration between the different communities living in Miami-Dade County; and

**WHEREAS**, the Community Performing Arts Association, Inc., is a not-for-profit organization; and

**WHEREAS**, the Cultural Integration Day is a district event, as defined in the attached Fee Waiver/In-kind Service Application and the in-kind services shall be funded from the District 10 In-kind Reserve Fund,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department and Miami-

Dade Police Department for the September 16, 2007 Cultural Integration Day event in an amount not to exceed \$5,555.00 to be funded from the District 10 In-kind Reserve Fund.



The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Community Performing Arts Association, Inc. for their "Cultural Integration Day" event held on September 16, 2007.

In-kind services have been requested in an amount not to exceed \$4,831 from the Miami-Dade Park and Recreation Department for waiver of the Ruben Dario Park facility fees and for the use of their show mobile and \$724 from Miami-Dade Police Department for police services for a total in-kind amount of \$5,555. This event will be funded from District 10 in-kind reserve fund.

In FY 2006-07, the Community Performing Arts Association, Inc. received a total of \$7,968 in County funding (\$750 from District 11 discretionary reserve, \$1,000 from District 12 discretionary reserve, and \$6,218 from the Department of Cultural Affairs).
