RESOLUTION APPROVING THE PLAT OF FOUNTAINS AT SAN SIMEON PARK, LOCATED IN THE NORTH 1/2 OF SECTION 31, TOWNSHIP 51 SOUTH, RANGE 42 EAST (NE 215 STREET AND SAN SIMEON WAY)

WHEREAS, 46 Acres, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as FOUNTAINS AT SAN SIMEON PARK, the same being a replat of a portion of Tract A of "Western Electric Site", according to the plat thereof, as recorded in Plat Book 102, at Page 70, of the Public Records of Miami-Dade County, Florida, lying and being in the North 1/2 of Section 31, Township 51 South, Range 42 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.



RECOMMENDATION

The following plat meets concurrency and is hereby submitted for consideration by the Board of County Commissioners for approval. The Miami-Dade County Plat Committee recommends approval and recording of the plat listed below. This plat is bounded on the north by NE 215 Street, on the east by NE 5 Place, on the south by approximately San Simeon Way, and on the west by approximately San Simeon Way.

BACKGROUND

FOUNTAINS AT SAN SIMEON PARK (T-22589)

- Located in Section 31, Township 51 South, Range 42 East
- Commission District: 1
- Zoning: PAD
- Proposed Usage: Public park
- Number of parcels: 1

PLAT RESTRICTIONS

- That NE 215th Street, as shown on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.

- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That the utility easements, shown by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.
- A 2-foot easement, as recorded on the plat of "Western Electric Site", Plat Book 102, Page 70, is hereby reserved for fire hydrants, guard rails and street lights adjacent to the public Right-of-Way within this subdivision.

- Monuments. Bonded under bond number 7741 for the amount of \$3,300.00.
