

RESOLUTION NO. R-1251-07

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE POLICE DEPARTMENT AND THE MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE JUNE 3, 2007 ANNUAL TELETHON SPONSORED BY LIGA CONTRA EL CANCER, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,662.00 TO BE FUNDED IN PART FROM THE COUNTYWIDE IN-KIND RESERVE FUND AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE IN-KIND RESERVE FUND

WHEREAS, Liga Contra el Cancer, Inc. has requested in-kind services from the Miami-Dade Police Department and the Miami-Dade Fire Rescue Department for the June 3, 2007 Annual Telethon in an amount not to exceed \$2,662.00 (see attached Fee Waiver/In-kind Services Application); and

WHEREAS, the purpose of the Annual Telethon is to promote cancer awareness and to provide free medical care and diagnostic services to indigent patients throughout Miami-Dade County; and

WHEREAS, Liga Contra el Cancer, Inc. is a not-for-profit organization; and

WHEREAS, the Annual Telethon is a special event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$1,342.00 of the in-kind services shall be funded from the Countywide In-kind Reserve Fund and \$1,320.00 shall be funded from the Fire In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Police Department and Miami-Dade Fire Rescue Department for the June 3, 2007 Annual Telethon in an amount not to exceed \$2,662.00 to be funded in part from the Countywide In-kind Reserve Fund and in part from the non-ad valorem portion of the Fire Rescue In-kind Reserve Fund.

The foregoing resolution was sponsored by Commissioner Joe A. Martinez, Commissioner Jose "Pepe" Diaz and Commissioner Rebeca Sosa and offered by Commissioner **Jose "Pepe" Diaz**, who moved its adoption. 



Subject: Countywide In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Liga Contra el Cancer, Inc. for their League Against Cancer event held on June 3, 2007.

In-kind services have been requested in an amount not to exceed \$1,342.00 from the Miami-Dade Police Department for police services and \$1,320 from Miami Dade County Fire Department for fire rescue and paramedic services for a total in-kind amount of \$2,662. This event will be funded in part from the countywide in-kind reserve fund and in part from the non-ad valorem portion of the Fire Rescue District Budget.
