

Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a for-profit organization the Haitian RARA Fest, Corporation event held on June 30, 2007 for their Haitian Rara Fest Summer 2007.

In-kind services have been requested in an amount not to exceed \$1,500 from the Miami-Dade Park and Recreation Department for use of their stage. This event will be funded from the District 3 in-kind reserve fund.

In FY 2006-07, the Haitian RARA Fest, Corporation has not received any County funding for this event.
