

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE POLICE DEPARTMENT, THE MIAMI-DADE PARK AND RECREATION DEPARTMENT, AND THE MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE SEPTEMBER 2, 2007 "THE SOUL OF A MAN CELEBRATION: JAZZ UNDER THE STARS" EVENT SPONSORED BY THE SOUTH FLORIDA BOYS CHOIR, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$16,390.00 TO BE FUNDED IN PART FROM THE COUNTYWIDE IN-KIND RESERVE FUND, AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE IN-KIND RESERVE FUND

WHEREAS, the South Florida Boys Choir, Inc. has requested in-kind services from the Miami-Dade Police Department, the Miami-Dade Park and Recreation Department, and the Miami-Dade Fire Rescue Department for the September 2, 2007 "The Soul of a Man Celebration: Jazz Under The Stars" event in an amount not to exceed \$16,390.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, "The Soul of a Man Celebration: Jazz Under The Stars" event promotes jazz culture awareness to the community, while raising funds to support the South Florida Boys Choir; and

WHEREAS, the South Florida Boys Choir, Inc. is a not-for-profit organization; and

WHEREAS, "The Soul of a Man Celebration: Jazz Under The Stars" event is a special event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$15,930.00 of the in-kind services shall be funded from the Countywide In-kind Reserve Fund and \$460.00 of the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Police Department, the Miami-Dade Park and Recreation Department, and the Miami-Dade Fire Rescue Department for the September 2, 2007 "The Soul of a Man Celebration: Jazz Under The Stars" event in an amount not to exceed \$16,390.00 to be funded in part from the Countywide In-kind Reserve Fund and in part from the non-ad valorem portion of the Fire Rescue In-kind Reserve Fund.

The foregoing resolution was sponsored by Commissioner Dennis C. Moss and offered by Commissioner **Jose "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:

Subject: Countywide In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the South Florida Boys Choir, Inc. for "The Soul of a Man Celebration: Jazz Under The Stars" held on September 2, 2007.

In-kind services have been requested in an amount not to exceed \$1,550 from the Miami-Dade Police Department for police services and \$14,380 from the Miami-Dade Park and Recreation Department and \$460 from the Miami Dade Fire Rescue Department for personnel for a total in-kind amount of \$16,390. This event will be funded in part from the countywide in-kind reserve fund and in part from the non-ad valorem portion of the Fire Rescue District Budget.

In FY 2006-07, the South Florida Boys Choir, Inc. received \$50,000 from the General Fund.
