RESOLUTION NO. R-1369-07

RESOLUTION APPROVING THE DESIGNATION OF
N. KENDALL DRIVE BETWEEN S.W. 117 AVENUE TO S.W.
127 AVENUE AS "AMBASSADOR ARMANDO
VALLADARES DRIVE"

WHEREAS, during the 2007 regular session, the Florida Legislature passed CS/SB 138, which among other road designations, designates N. Kendall Drive between S.W. 117 Avenue to S.W. 127 Avenue as "Ambassador Armando Valladares Drive"; and

WHEREAS, section 334.071, Florida Statutes, provides that the installation of road designation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road designation; and

WHEREAS, before the Florida Department of Transportation will install signs reflecting the Ambassador Armando Valladares Drive road designation, this Board will need to pass a resolution approving the road designation,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board approves the designation of N. Kendall Drive between S.W. 117 Avenue to S.W. 127 Avenue as "Ambassador Armando Valladares Drive."
