



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT AND THE MIAMI DADE ELECTIONS DEPARTMENT FOR THE JANUARY 28 - FEBRUARY 2, 2008 PARENTS AGAINST VIOLENCE EVENT SPONSORED BY REGIS HOUSE, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,290.00 TO BE FUNDED FROM THE DISTRICT 3 IN-KIND RESERVE FUND

WHEREAS, Regis House, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department and the Miami-Dade Elections Department for the January 28 - February 2, 2008 Parents Against Violence event in an amount not to exceed \$2,290.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the Parents Against Violence event is to raise public awareness on violence within our communities; and

WHEREAS, Regis House, Inc. is a not-for-profit organization; and

WHEREAS, the Parents Against Violence event is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the District 3 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department and the Miami-Dade Elections Department for the January 28 - February 2, 2008 Parents Against Violence event in an amount not to exceed \$2,290.00 to be funded from the District 3 In-kind Reserve Fund.

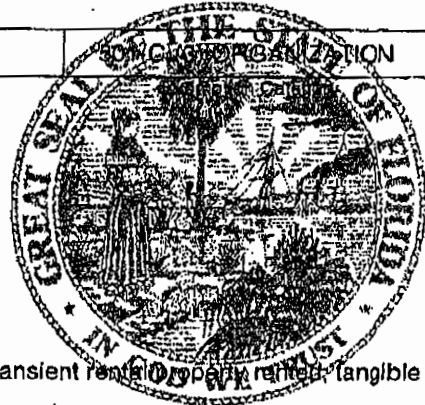

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Regis House, Inc. for the Parent Against Violence Week event held on January 28 - February 2, 2008.

In-kind services have been requested in an amount not to exceed \$2,066 from the Miami-Dade Park and Recreation Department for the use of a large show mobile and \$224 from the Miami-Dade Elections Department for use of chairs and tables, for a total in-kind amount of \$2,290. This event will be funded from the District 3 in-kind reserve fund.

In FY 2007-08, the Regis House, Inc. has received \$204,500 from the General Fund.
