

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE TRANSIT AGENCY FOR THE JANUARY 19, 2008 MARTIN LUTHER KING, JR. DAY OF SERVICE SPONSORED BY SERVICE FOR PEACE, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$8,083.00 TO BE FUNDED FROM THE DISTRICT 3 IN-KIND RESERVE FUND

WHEREAS, Service For Peace, Inc. has requested in-kind services from the Miami-Dade Transit Agency for the January 19, 2008 Martin Luther King, Jr. Day of Service event in an amount not to exceed \$8,083.00(see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the Martin Luther King, Jr. Day of Service event is to allow 600 volunteers to travel to 9 different sites to perform beautification projects that will enhance inner city areas throughout Miami-Dade County; and

WHEREAS, Service For Peace, Inc. is a not-for-profit organization; and

WHEREAS, the Martin Luther King, Jr. Day of Service event is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the District 3 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Transit Agency for the January 19, 2008 Martin Luther King, Jr. Day of Service event in an amount not to exceed \$8,083.00 to be funded from the District 3 In-kind Reserve Fund.





Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Service For Peace, Inc. for the MLK Day Services event held on January 19, 2008.

In-kind services have been requested in an amount not to exceed \$8,083 from the Miami-Dade Transit Agency for transportation services. This event will be funded from the District 3 in-kind reserve fund.
