

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE TRANSIT AGENCY FOR THE MARCH 29, 2008 "MARCH FOR PARKS 2008" EVENT SPONSORED BY THE OPERATION GREEN LEAVES, INC. A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,145.00 TO BE FUNDED IN PART FROM THE DISTRICT 8 IN-KIND RESERVE FUND AND IN PART FROM THE DISTRICT 9 IN-KIND RESERVE FUND

WHEREAS, the Operation Green Leaves, Inc. has requested in-kind services from the Miami-Dade Transit Agency for the March 29, 2008 "March For Parks 2008" event in an amount not to exceed \$4,145.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "March For Parks 2008" event is to increase community awareness and participation among inner city communities by exposing them to environmental education activities, recreational opportunities and employment opportunities at local, state, regional and national parks; and

WHEREAS, Operation Green Leaves, Inc. is a not-for-profit organization; and

WHEREAS, the "March For Parks 2008" event is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$2,072.50 of the in-kind services shall be funded from the District 8 In-kind Reserve Fund and \$2,072.50 of the in-kind services shall be funded from the District 9 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Transit Agency for the March 29, 2008 "March

For Parks 2008" event in an amount not to exceed \$4,145.00 to be funded in part from the District 8 In-kind Reserve Fund and in part from the District 9 In-kind Reserve Fund.



Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Operation Green Leaves, Inc. for the March for Parks 2008 event held on March 28, 2008.

In-kind services have been requested in an amount not to exceed \$4,145 from the Miami-Dade Transit Agency Park for transportation services. This event will be funded from Districts 8 (\$2,072.50) and 9 (\$2,072.50) in-kind reserve funds.

In FY 2007-08, Operation Green Leaves, Inc. has received \$17,181 from the General Fund.
