

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT AND THE MIAMI-DADE TRANSIT AGENCY FOR THE MARCH 30, 2008 CELEBRITY 5K SPONSORED BY COMMUNITY PARTNERSHIP FOR HOMELESS, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,353.00 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

WHEREAS, Community Partnership For Homeless, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department and Miami-Dade Transit Agency for the March 30, 2008 Celebrity 5K in an amount not to exceed \$4,353.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the Celebrity 5K is a marathon race with a focus to raise funds in support of homeless awareness, and in order to provide shelter and distribute food to the homeless community; and

WHEREAS, Community Partnership For Homeless, Inc. is a not-for-profit organization; and

WHEREAS, the Celebrity 5K is a special event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the Countywide In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department and the

Miami-Dade Transit Agency for the March 30, 2008 Celebrity 5K in an amount not to exceed \$4,353.00 to be funded from the Countywide In-kind Reserve Fund.

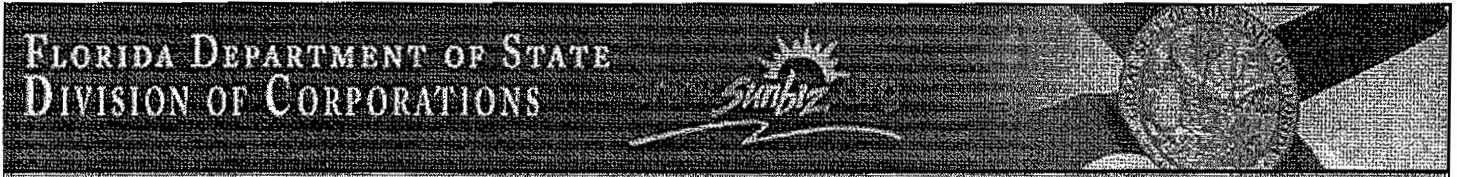

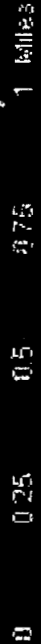

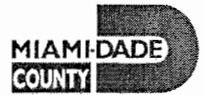

Subject: Countywide In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Community Partnership for Homeless Inc. for the Celebrity 5K event held for March 30, 2008.

In-kind services have been requested in an amount not to exceed \$945 from the Miami-Dade Park and Recreation Department for the use of a show mobile and \$3,407.44 from the Miami-Dade Transit Agency for transportation services for a total in-kind amount of \$4,352.44. This event will be funded from the countywide in-kind reserve fund.

In FY 2007-08, Community Partnership for Homeless, Inc. has received no County funding for this event.
