

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE MARCH 17-23, 2008 WORLD GOLF CHAMPIONSHIPS - CA CHAMPIONSHIP SPONSORED BY SOUTH FLORIDA GOLF FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$26,119.00 TO BE FUNDED FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT IN-KIND RESERVE FUND

WHEREAS, South Florida Golf Foundation, Inc. has requested in-kind services from the Miami-Dade Fire Rescue Department and from the Miami-Dade Police Department for the March 17-23, 2008 World Golf Champions -CA Championship in an amount not to exceed \$95,693.44 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, of those in-kind services, those being requested from the Miami-Dade Fire Rescue Department are in an amount not to exceed \$26,119.00; and

WHEREAS, the World Golf Champions -CA Championship is part of the PGA Tour golf charity event that attracts over seventy-five (75) professional golf players to raise funds for local South Florida charities such as the Make A Wish Foundation, Miami Children's Hospital Foundation, Baptist Children's Hospital Foundation, The Nate Moore Foundation, the American Cancer Society Hope Lodge, the First Tee, and many others benefiting sick and underprivileged children; and

WHEREAS, South Florida Golf Foundation, Inc is a not-for-profit organization; and

WHEREAS, the World Golf Champions -CA Championship event is a major event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Fire Rescue Department for the March 17-23, 2008 World Golf Champions –CA Championship event in an amount not to exceed \$26,119.00 to be funded the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund.



Through their efforts with this tournament, the foundation has raised over \$12 million dollars for local South Florida charities. Realizing that the champions and leaders of tomorrow come from strong communities of today, the SFGF's main focus for charitable donations are local charities benefiting sick and underprivileged children. Local recipients include the Make-A-Wish Foundation, Miami Children's Hospital Foundation, Baptist Children's Hospital Foundation, The Nat Moore Foundation, the American Cancer Society Hope Lodge, and The First Tee to name a few.

The SFGF has a dedicated Board of Directors comprised of local business leaders who, through their love of the game of golf, volunteer their time and donate generously to support the efforts of the foundation. The SFGF Board Members either participate annually as part of the fifteen hundred volunteers that support the golf tournament, or become corporate sponsors and either purchase or solicit sponsorship packages and tickets packages. Through their dedication, the SFGF Board Members have united businesses, organizations and individuals with a common goal to nurture and protect healthy, happy children and promote stronger, safer communities.

You can become a member of this select group of dedicated individuals. The SFGF realizes that everyone has time limitations and many other responsibilities. Therefore, we offer two levels for participation. As a Board Member you would be a voting member of the SFGF and be responsible for decisions on the direction and operation of the Foundation. There would be three meetings per year to attend and your commitment to the SFGF would be \$50,000 in a combination of purchasing or soliciting sponsor packages and ticket packages, volunteering, supporting the annual Charity Ball, and participating in the annual Blue Monster charity golf events at Doral. 

Dear Sir or Madam:

This is in response to the Amendment to your organization's Articles of Incorporation, filed with the state on May 18, 2000. We have updated our records to reflect the name change as indicated above.

Our records indicate that a determination letter issued in June 1988 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in section 509(a)(2).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.

Your organization is not required to file federal income tax returns unless it is subject to the tax on unrelated business income under section 511 of the Code. If your organization is subject to this tax, it must file an income tax return on the Form 990-T, Exempt Organization Business Income Tax Return. In this letter, we are not determining whether any of your organization's present or proposed activities are unrelated trade or business as defined in section 513 of the Code.


The law requires you to make your organization's annual return available for public inspection without charge for three years after the due date of the return. You are also required to make available for public inspection a copy of your organization's exemption application, any supporting documents and the exemption letter to any individual who requests such documents in person or in writing. You can charge only a reasonable fee for reproduction and actual postage costs for the copied materials. The law does not require you to provide copies of public inspection documents that are widely available, such as by posting them on the Internet (World Wide Web). You may be liable for a penalty of \$20 a day for each day you do not make these documents available for public inspection (up to a maximum of \$10,000 in the case of an annual return).

Because this letter could help resolve any questions about your organization's exempt status and foundation status, you should keep it with the organization's permanent records.



Subject: Fire District In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The fire district in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization the South Florida Golf Foundation for the annual World Golf Championships – CA Championship event held on March 17 -23, 2008.

In-kind services have been requested in an amount not to exceed \$26,119 from the Miami-Dade Fire Rescue Department for personnel services. This event will be funded from the non-ad valorem in-kind reserve of the fire rescue district budget.

In FY 2007-08, the South Florida Golf Foundation has requested, for your consideration on the same agenda, under the sponsorship of Commissioner Diaz, a request for in-kind services in the amount not to exceed \$69,575 from the countywide in-kind reserve funding for Police Services for the same event.
