RESOLUTION NO.      **R-536-08**

RESOLUTION APPROVING THE CODESIGNATION OF THE  
CORNER OF W. FLAGLER STREET AND LEJEUNE ROAD  
IN HONOR OF ARISTIDES SASTRE

**WHEREAS**, during the 2007 regular session, the Florida Legislature passed Senate Bill 138, which among other road designations, designates the corner of W. Flagler Street also known as State Road 968, and LeJeune Road, also known as State Road 953 in honor of Aristides Sastre; and

**WHEREAS**, Section 334.071, Florida Statutes, provides that the erection of markers shall be contingent upon the appropriate city or county commission passing a resolution in support of the particular honorary designation; and

**WHEREAS**, on September 27, 2007 the City of Miami passed resolution 07-0538, approving said codesignation,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board joins the City of Miami and approves the codesignation of the corner of W. Flagler Street, State Road 968, and LeJeune Road, State Road 953 in honor of Aristides Sastre.
