Subject: Contract Award Recommendation for Alexander Orr Jr. Water Treatment Plant Removal of Calcium Carbonate Deposit - Project No: N/A; Contract No: W-836

This item was amended at the March 11, 2008 Governmental Operations and Environment Committee due to scrivener's errors in the "Explanation" section (second paragraph, page 3). Specifically, item was amended to include Bid Item No.5, as well as to correct the estimate of \$6 million to \$5,925,000 and the difference in ranges from \$400,000-\$2,579,000 to \$50,000-\$2,504,000.

Recommendation

This Recommendation for Award of a construction Contract Number W-836 between Atlantic Civil, Inc., and Miami-Dade County has been prepared by the Miami-Dade Water and Sewer Department (MDWASD) and is recommended for approval. At the present time, the existing lagoon at the Alexander Orr Jr. Water Treatment Plant (AOWTP) is reaching full capacity; this project will provide MDWASD adequate storage capacity for the calcium carbonate residuals of water production operation at the AOWTP.

Scope

PROJECT NAME: Alexander Orr Jr. Water Treatment Plant Removal of Calcium Carbonate Deposit

PROJECT DESCRIPTION: The project consists of furnishing all labor, materials and equipment necessary to haul and legally dispose of the calcium carbonate residuals in a lagoon produced at the AOWTP. The calcium carbonate is the material removed from the well during the water softening process. The material is inert and non-toxic, in its dry stage (very fine powder), but when mixed with water it forms a slurry paste.

The work includes, but is not limited to the following: clearing, excavating, loading trucks with watertight bodies and covers and hauling away approximately 175,000 cubic yards of calcium carbonate; furnishing all labor, materials and equipment necessary to breach the existing dike and reconstructing it upon completion of work; legally disposing of the material off site; constructing a truck wash station to be used for the duration of the project; removing the truck wash station at the end of the project; performing street cleaning along the calcium carbonate haul route; survey work; furnishing traffic control; and all other miscellaneous and appurtenant work for a complete project.

It is MDWASD's intent to obtain a complete, functional, and satisfactory installation under this project and any items of labor, equipment or materials (which may be reasonably assumed as necessary to accomplish this task) shall be supplied whether or not they are specifically shown on the plans or stated in the specifications. The contractor shall provide all sheeting, shoring, bracing and all other labor, material or equipment required to preclude damage to, or loss of functionality of, any existing facility or system.

EXPLANATION

MDWASD received ten bids for this project, seven of the bids were under the Engineer's estimate. The low bidder is 31 percent under the Engineer's estimate and the difference between the two lowest bidders is 2.6 percent.

Bid Item No. 4 and 5 – Loading, Hauling, and Legal Disposing of Calcium Carbonate - accounts for the difference between MDWASD's estimate of \$5,925 million and the lower bids received (the difference ranges from \$50,000 to \$2,504,000). The disposal location of the calcium carbonate residual has a significant impact on the contractor's price bid. The contractor that obtains the closets and most economical disposal site has the best chance of being the low bidder.

Therefore, MDWASD's recommendation is to award this contract to the lowest responsive and responsible bidder, Atlantic Civil, Inc. The Engineer has reviewed the unit prices submitted by Atlantic Civil and determined that the bid is reasonable. Atlantic Civil has been awarded five contracts in the last five years. Contract W-812 was with MDWASD, and was completed in a satisfactory manner. Because this was prior to implementation of AO 3-42, there are no evaluations listed in the CIIS database.



This project is being resubmitted because it was not advertised in the six-month time period.







CONTRACT

THIS CONTRACT, made and entered into on the _____ day
of _____, 20_____, by and between Miami-Dade County, Florida,
party of the first part (hereinafter sometimes called the "County"), and Atlantic Civil, Inc.
party of the second part (hereinafter sometimes called "Contractor");

WITNESSETH

That the parties hereto, for and in consideration of the covenants and agreements hereinafter set forth, mutually agree as follows, to wit:

1. That the Contractor shall furnish all labor, materials and equipment and perform all work in the manner and form provided by the Contract Documents covering the Project of the County known and identified as

**"Alexander Orr Jr. Water Treatment Plant
Removal of Calcium Carbonate Deposit,
Contract No. W-836"**

for the aggregate amount reflected by the Proposal, said aggregate amount being of **Five Million Five Hundred Fifty Three Thousand Eight Hundred Ninety Three Dollars and Forty Two Cents (U.S. Dollars) \$5,553,893.42.**

2. That the Contractor shall begin the work to be performed under this Contract on a day to be specified in a written order issued by the Engineer, and shall fully complete all work hereunder within the time or times stated in the Proposal.

3. That the County shall pay to the Contractor for the faithful performance of this Contract, in lawful money of the United States, and subject to additions and deductions as provided in the Contract Documents, the total amount of his proposal as set forth above at the times and in a manner stated in the General Covenants and Conditions of the Contract Documents.

4. It is further mutually agreed that if at any time after the execution of this Contract, Surety Performance and Payment Bond, the County shall deem the surety upon such bonds to be unsatisfactory, or if for any reason such bond shall become inadequate to cover the performance of the work, the Contractor shall at his own expense, within five (5) days after the receipt of notice from the County to do so, furnish an additional bond or bonds in such form and amount and with such surety or sureties as shall be satisfactory to the County. In such event, no further payment to the Contractor shall be deemed to be due under this Contract until such new or additional security shall have been furnished in a manner and form satisfactory to the County.

5.
