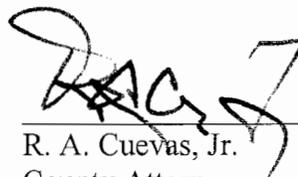

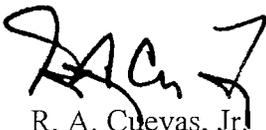

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MAY 3, 2008 “PAZ, JUSTICIA, Y LEGALIZACION PARA LOS INMIGRANTES” EVENT SPONSORED BY CASIOPEIA CORPORATION, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$761.00 TO BE FUNDED FROM THE DISTRICT 5 IN-KIND RESERVE FUND

**WHEREAS**, CASIOPEIA Corporation has requested in-kind services from the Miami-Dade Park and Recreation Department for the May 3, 2008 “Paz, Justicia, y Legalizacion Para Los Inmigrantes” event in an amount not to exceed \$761.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the “Paz, Justicia, y Legalizacion Para Los Inmigrantes” event is to conduct a free orientation and educational workshop for Miami-Dade immigrants on their employment rights and about laws at the federal, state, and local levels; and

**WHEREAS**, CASIOPEIA Corporation is a not-for-profit organization; and

**WHEREAS**, the “Paz, Justicia, y Legalizacion Para Los Inmigrantes” event is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the District 5 In-kind Reserve Fund,

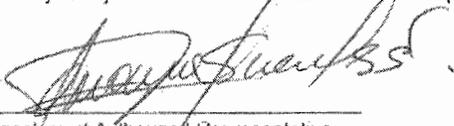

## Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A retroactive fee waiver for in-kind services is being requested by a not-for-profit organization CASIOPEIA Corporation for the "Legalizacion Para Los Inmigrantes" for event held on May 3, 2008.

In-kind services have been requested in an amount not to exceed \$761 from the Miami-Dade Park and Recreation Department for the use of 20 x 24 stage. This event will be funded from the District 5 in-kind reserve fund.

In FY 2007-08, CASIOPEIA Corporation has received no County funding for this event.
