

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MAY 4, 2008 "ONE PEOPLE, ONE COMMUNITY" MULTI-CULTURAL STREET FESTIVAL SPONSORED BY WECARE OF SOUTH DADE, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,398.00 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

**WHEREAS**, WeCare of South Dade, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the May 4, 2008 "One People, One Community" Multi-Cultural Street Festival in an amount not to exceed \$2,398.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the "One People, One Community" Multi-Cultural Street Festival is a free street festival that brings together individuals and families of various backgrounds to learn and explore various diverse cultures while promoting unity, love and community collaboration among residents in Miami-Dade County; and

**WHEREAS**, WeCare of South Dade, Inc. is a not-for-profit organization; and

**WHEREAS**, the "One People, One Community" Multi-Cultural Street Festival is a major event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the Countywide In-kind Reserve Fund,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the May

4, 2008 "One People, One Community" Multi-Cultural Street Festival in an amount not to exceed \$2,398.00 to be funded from the Countywide In-kind Reserve Fund.





## Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

## Background

A retroactive fee waiver for in-kind services is being requested by a not-for-profit organization We Care of South Dade, Inc. for the One People, One Community, and Multi-Cultural Street Festival event held on May 4, 2008.

In-kind services have been requested in an amount not to exceed \$2,398 from the Miami-Dade Park and Recreation Department for the use of two (2) – 24 x 40 stages and 1 set of bleachers. This event will be funded from the countywide in-kind reserve fund.

In FY 2007-08, We Care of South Dade, Inc. has received \$108,035 from the General Fund and \$1,057 from District 8 office funds.
