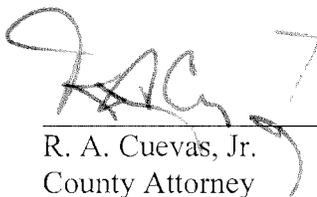

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE POLICE DEPARTMENT AND MIAMI-DADE COUNTY FIRE DEPARTMENT FOR THE JUNE 1, 2008 LEAGUE AGAINST CANCER FUNDRAISER SPONSORED BY THE LIGA CONTRA EL CANCER, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,585.00 TO BE FUNDED IN PART FROM THE COUNTYWIDE IN-KIND RESERVE FUND, AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT IN-KIND RESEVE FUND

**WHEREAS**, the Liga Contra el Cancer, Inc. has requested in-kind services from the Miami-Dade Police Department and Miami-Dade County Fire Department for the June 1, 2008 League Against Cancer event in an amount not to exceed \$2,585.00 (see attached Fee Waiver/In-kind Services Application); and

**WHEREAS**, the purpose of the League Against Cancer fundraiser event is to promote cancer awareness, provide free medical care and diagnostic services to indigent patients through Miami-Dade County; and

**WHEREAS**, the Liga Contra el Cancer, Inc. is a not-for-profit organization; and

**WHEREAS**, the League Against Cancer is a special event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$1,100.00 of the in-kind services shall be funded from the Countywide In-kind Reserve Fund and \$1,485.00 shall be funded from the Fire Rescue District In-kind Reserve Fund,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board retroactively authorizes in-kind services from the Miami-Dade Police Department and the Miami-Dade County Fire Department in the amount not to exceed \$2,585.00 to

be funded in part from the Countywide In-kind Reserve Fund and in part from the non-ad valorem portion of the Fire Rescue District In-Kind Reserve Fund for the June 1, 2008 League Against Cancer event, as outlined in the attached budget incorporated herein by reference.

The Prime Sponsor of the foregoing resolution is Commissioner Joe A. Martinez, and the Co-Sponsor is Commissioner Rebeca Sosa. It was offered by Commissioner

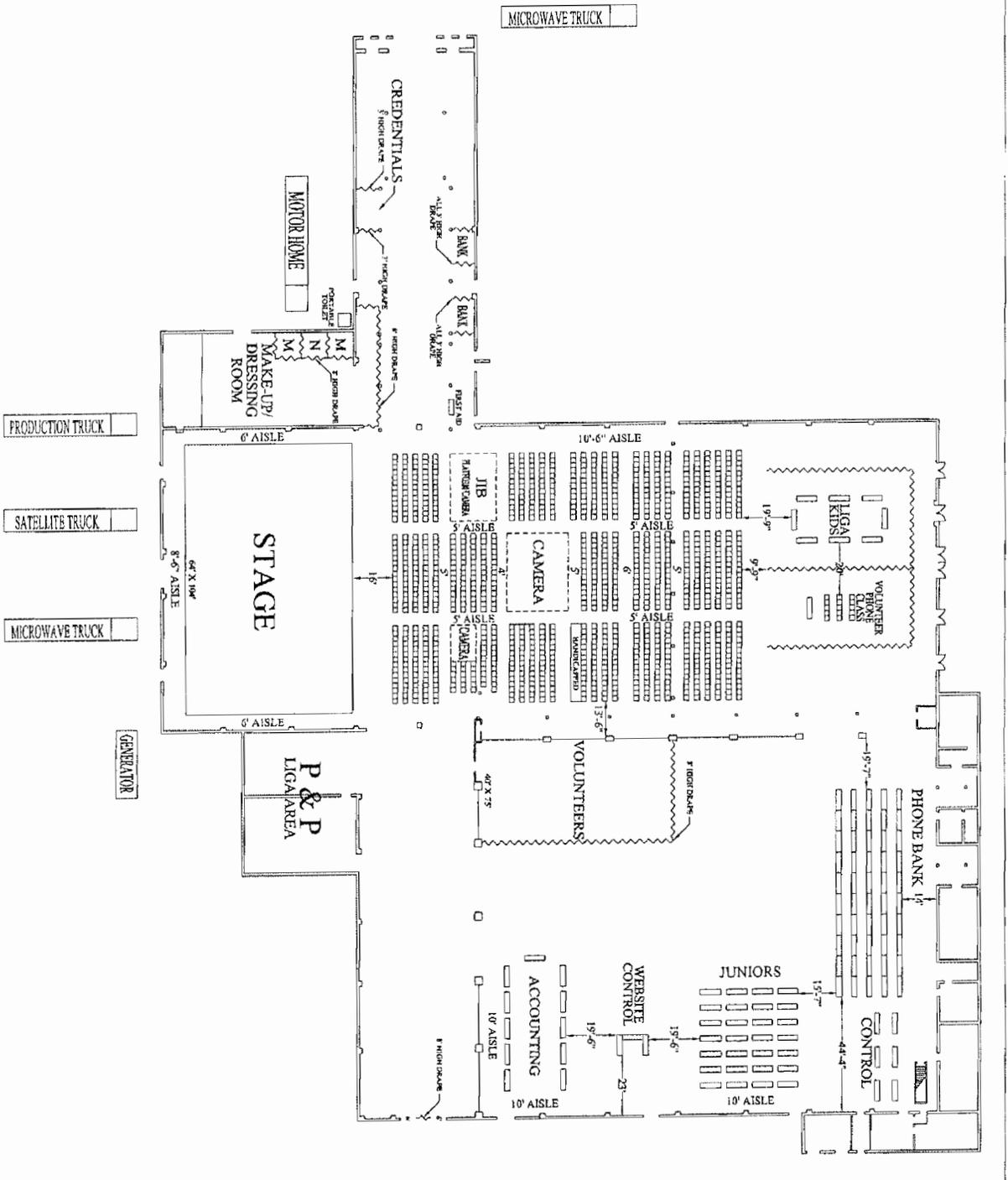

**Subject:** Countywide and Fire Rescue District In-Kind Request Recommendation

---

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide and fire rescue district in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Liga Contra el Cancer, Inc. for their League Against Cancer event held on June 1, 2008.

In-kind services have been requested in an amount not to exceed \$1,100 from the Miami-Dade Police Department for police services and \$1,485 from Miami-Dade Fire Rescue Department for fire rescue and paramedic services for a total in-kind amount of \$2,585. This event will be funded in part from the countywide in-kind reserve fund and in part from the non-ad valorem portion of the fire rescue district in-kind reserve fund.

In FY 2007-08, the Liga Contra el Cancer, Inc. has received \$225,000 in County funding from the following funds: \$175,000 from the General Fund, \$10,000 from District 5 office funds, \$10,000 from District 6 discretionary reserve, \$10,000 from District 11 discretionary reserve, \$5,000 from District 12 discretionary reserve, \$5,000 from District 13 office funds and \$10,000 from the Mayor's discretionary reserve.
