

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE JUNE 12 - 15, 2008 “MIAMI SPRINGS OPTIMIST CLUB CHARITY DOLPHIN FISHING TOURNAMENT AND COMMUNITY FISH FRY” SPONSORED BY OPTIMIST CLUB OF MIAMI SPRINGS FLORIDA INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,866.00 TO BE FUNDED FROM THE DISTRICT 6 IN-KIND RESERVE FUND

WHEREAS, the Optimist Club of Miami Springs Florida, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the June 12-15, 2008 “Miami Springs Optimist Club Charity Dolphin Fishing Tournament and Community Fish Fry” event in an amount not to exceed \$3,866.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the “Miami Springs Optimist Club Charity Dolphin Fishing Tournament and Community Fish Fry” event is a fund raiser for the Optimist Club that sponsors youth activities for various communities; and

WHEREAS, the Optimist Club of Miami Springs Florida, Inc. is a not-for-profit organization; and

WHEREAS, the “Miami Springs Optimist Club Charity Dolphin Fishing Tournament and Community Fish Fry” event is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$3,866.00 of the in-kind services shall be funded from the District 6 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively





Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization the Optimist Club of Miami Springs Florida, Inc. for the Miami Springs Optimist Club Charity Dolphin Fishing Tournament and Community Fish Fry event held on June 12-15, 2008.

In-kind services have been requested in an amount not to exceed \$3,866 from the Miami-Dade Park and Recreation Department for the use of a large show mobile. This event will be funded from the District 6 in-kind reserve fund.

In FY 2007-08, the Optimist Club of Miami Springs Florida, Inc. has received \$17,000 from the General Fund and \$1,000 from District 6 discretionary reserve.
