

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MAY 30, 2008 “COMMUNITY FAMILY FUN” EVENT SPONSORED BY BETHEL FULL GOSPEL BAPTIST CHURCH, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,182.00 TO BE FUNDED FROM THE DISTRICT 9 IN-KIND RESERVE FUND

**WHEREAS**, Bethel Full Gospel Baptist Church has requested in-kind services from the Miami-Dade Park and Recreation Department for the May 30, 2008 - “Community Family Fun” event in an amount not to exceed \$3,182.00 (see attached Fee Waiver/In-kind Service Application); and



## Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Bethel Full Gospel Baptist Church, Inc. for the Community Family Fun event held on May 30, 2008.

In-kind services have been requested in an amount not to exceed \$3,182 from the Miami-Dade Park and Recreation Department for the use of a large show mobile and one (1) set of bleachers. This event will be funded from the District 9 in-kind reserve fund.

In FY 2007-08, Bethel Full Gospel Baptist Church, Inc. has received no County funding for this event.
