

RESOLUTION NO. **R-882-08**

RESOLUTION MODIFYING THE SCHEDULE OF TRANSIT
FARES, RATES AND CHARGES TO INCREASE THE
METRORAIL PARKING PERMIT FEE FROM \$6.25 TO \$10.00,
PER MONTH

WHEREAS, the Miami-Dade County Transit Department is in need of additional funds to support its mission and ongoing operations; and

WHEREAS, appropriate increases in Miami-Dade County Transit fares, rates and charges will demonstrate to the federal government the commitment Miami-Dade County has for supporting the operation and maintenance of the existing and potentially expanded transit system; and

WHEREAS, this commitment to increasing revenues for Miami-Dade Transit makes it more likely that Miami-Dade County will receive federal financial support for the North and East-West Corridor expansions of Metrorail; and

WHEREAS, Miami-Dade County Transit currently offers Metropass, Golden Passport, and Patriot Passport holders, and Miami-Dade Transit employees, the option of purchasing monthly parking permits for use at Metrorail surface parking lots and parking garages, at the cost of \$6.25, per month, (identified in the Schedule of Transit Fares, Rates and Charges at section IV, *Prepaid Passes*, item G, *Monthly Parking Permit*); and

WHEREAS, a cost of \$10.00, per month for such parking permits represents a more reasonable amount for the value of services provided, and would additionally provide further revenue to the Department,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board, effective

October 1, 2008, hereby modifies the Schedule of Transit Fares, Rates and Charges to increase the monthly Metrorail parking permit (identified in the Schedule of Transit Fares, Rates and Charges at section IV, *Prepaid Passes*, item G, *Monthly Parking Permit*), from \$6.25 per month to \$10.00 per month.

The Prime Sponsor of the foregoing resolution is Vice-Chairwoman Barbara J. Jordan. It was offered by Commissioner **Barbara J. Jordan**, who moved its adoption. The motion was seconded by Commissioner **Dorrin D. Rolle** and upon being put to a vote, the vote was as follows:
