LOVE, D-22733, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 33, TOWNSHIP 56 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY APPROXIMATELY SW 276 STREET, ON THE EAST BY APPROXIMATELY SW 152 AVENUE, ON THE SOUTH BY US 1 AND ON THE WEST BY APPROXIMATELY SW 153 AVENUE)

WHEREAS, Lesel Love, Jr. and Gwendolyn R. Love, husband and wife, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Southwest 1/4 of Section 33, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


