RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE GENERAL SERVICES ADMINISTRATION FOR THE JULY 13, 2008 "ZO'S SUMMER GROOVE BLOCK PARTY" EVENT SPONSORED BY THE ALONZO MOURNING CHARITIES, INC., A NOT-FORPROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$500.00 TO BE FUNDED IN PART FROM THE DISTRICT 3 AND DISTRICT 5 IN-KIND RESERVE FUNDS

WHEREAS, the Alonzo Mourning Charities, Inc. has requested in-kind services from the General Services Administration for the July 13, 2008 "Zo's Summer Groove Block Party" event in an amount not to exceed $\$ 500.00$ (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, "Zo's Summer Groove Block Party" will be a pre-game event to kick off the All-Star Basketball Game; and

WHEREAS, this free event which is open to the public will feature music, food, giveaways and entertainment; and

WHEREAS, Alonzo Morning Charities, Inc. is a not-for-profit public fundraising foundation; and

WHEREAS, "Zo's Summer Groove Block Party" is a special event, as defined in the attached Fee Waiver/In-kind Service Application and the in-kind services shall be funded in part from the District 3 and District 5 In-kind Reserve Funds,

Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Alonzo Mourning Charities, Inc. for their "Zo Summer Groove" event held on July 13, 2008.

In-kind services have been requested in an amount not to exceed $\$ 500$ from the General Services Administration for use of parcel " B ". This event will be funded in part from the District 3 ( $\$ 250$ ) and in part from District 5 ( $\$ 250$ ) in-kind reserve funds.

In FY 2007-08, Alonzo Mourning Charities, Inc. has received no County funding for this event.
