

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE AUGUST 9, 2008 "BACK TO SCHOOL CHAMPIONS" EVENT SPONSORED BY THE UDONIS HASLEM CHILDREN'S FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$716.00 TO BE FUNDED FROM THE DISTRICT 1 IN-KIND RESERVE FUND

**WHEREAS**, Udonis Haslem Children's Foundation, Inc., has requested in-kind services from the Miami-Dade Park and Recreation Department for the August 9, 2008 "Back to School Champions" event in an amount not to exceed \$716.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the "Back to School Champions" is to provide, among other things, back packs, school supplies and uniforms to underprivileged children; and

**WHEREAS**, Udonis Haslem Children's Foundation, Inc. is a not-for-profit organization; and

**WHEREAS**, the "Back to School Champions" event is a special event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$716.00 of the in-kind services shall be funded from the District 1 In-kind Reserve Fund,







## Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization the Udonis Haslem Children's Foundation, Inc. for the Back to School Champions event held on August 9, 2008.

In-kind services have been requested in an amount not to exceed \$716 from the Miami-Dade Park and Recreation Department for the use of a stage mobile. This event will be funded from the District 1 in-kind reserve fund.

In FY 2007-08, the Udonis Haslem Children's Foundation, Inc. has received no county funding for this event.
