

District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the City of North Miami event held on July 4, 2008 for their Annual July 4th Independence Day Celebration.

In-kind services have been requested in an amount not to exceed \$460 from the Miami-Dade Fire Rescue Department and \$2,366 from the Miami-Dade Park and Recreation Department for the use of a showmobile. This event will be funded in part from District 1 (\$230), District 2 (\$115), District 3 (\$1,906) and District 4 (\$115) in-kind reserve funds and in part from the non-ad valorem portion of the fire rescue district in-kind reserve.

In FY 2007-08, the City of North Miami has received no County funding for this event.
