

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE DECEMBER 21, 2007 "ANNUAL GREEN AND GOLD FOOTBALL GAME" SPONSORED BY WEST MIAMI MIDDLE COMMUNITY SCHOOL, A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,582.00 TO BE FUNDED FROM THE DISTRICT 6 IN-KIND RESERVE FUND

**WHEREAS**, West Miami Middle Community School has requested in-kind services from the Miami-Dade Park and Recreation Department for the December 21, 2007 "Annual Green and Gold Football Game" in an amount not to exceed \$2,582.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the Annual Green and Gold Football Game has been played for fifty years and brings together current students of West Miami Middle Community School, alumni, local business owners and community leaders; and

**WHEREAS**, West Miami Middle Community School is a not-for-profit organization; and

**WHEREAS**, the "Annual Green and Gold Football Game" event is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$2,582.00 of the in-kind services shall be funded from the District 6 In-kind Reserve Fund,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the

December 21, 2007 "Annual Green and Gold Football Game" event in an amount not to exceed \$2,582.00 to be funded from the District 6 In-kind Reserve Fund.



2. Your *Consumer's Certificate of Exemption* is to be used solely by your organization for your organization's customary nonprofit activities.
3. Purchases made by an individual on behalf of the organization are taxable, even if the individual will be reimbursed by the organization.
4. This exemption applies only to purchases your organization makes. The sale or lease to others by your organization of tangible personal property, sleeping accommodations or other real property is taxable. Your organization must register, and collect and remit sales and use tax on such taxable transactions. Note: Churches are exempt from this requirement except when they are the lessor of real property (Rule 12A-1.070, FAC).
5. It is a criminal offense to fraudulently present this certificate to evade the payment of sales tax. Under no circumstances should this certificate be used for the personal benefit of any individual. Violators will be liable for payment of the sales tax plus a penalty of 200% of the tax, and may be subject to conviction of a third degree felony. ## Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A retroactive fee waiver for in-kind services is being requested by a not-for-profit organization West Miami Middle Community School for the Annual Green and Gold Football Game scheduled for December 21, 2007.

In-kind services have been requested in an amount not to exceed \$2,582 from the Miami-Dade Park and Recreation Department for four (4) set of bleachers to accommodate 1,500 participants. This event will be funded from the District 6 in-kind reserve fund.

In FY 2007-08, West Miami Middle Community School has received no County funding for this event.
