## BACKGROUND

QUAIL ROOST WEST (T-22865)

- Located in Section 2, Township 56 South, Range 39 East
- Commission District: 8

- Proposed Usage: Commercial buildings

## PLAT RESTRICTIONS

- That SW 200th Street, SW 127th Avenue, and SW 127th Court, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.

- That the use of septic tanks will not be permitted on any tract within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

**DEVELOPER'S OBLIGATION**

- Paving, milling, sidewalks, resurfacing, street name signs, drainage, guardrail, striping and monumentation. Bonded under bond number 7800 in the amount of \$117,164.00.

RESOLUTION APPROVING THE PLAT OF QUAIL ROOST WEST, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 2, TOWNSHIP 56 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY APPROXIMATELY SW 197 TERRACE, ON THE EAST BY SW 127 AVENUE, ON THE SOUTH BY SW 200 STREET, AND ON THE WEST BY SW 127 COURT)

**WHEREAS**, Quail Roost Partners, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as QUAIL ROOST WEST, the same being a replat of a portion of Tract 16 of "Plat of Portion of Tropico", according to the plat thereof, as recorded in Plat Book 2, at Page 57, of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 2, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.
