District Specific and Fire District In-Kind Reserve Request Recommendation

#### Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific and fire district in-kind reserve balances allow for the funding of this request.

#### Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Kids and Families Foundation, Inc. for the Christmas in July event held on July 20, 2008.

In-kind services have been requested in an amount not to exceed \$5,116 from the Miami-Dade Park and Recreation Department for the use of one (1) medium show mobile, one (1) 85kw generator, one (1) arena and 10 vendor spaces at Tropical Park, \$11,200 from the Miami-Dade Police Department for personnel services, and \$1,438 from the Miami-Dade Fire Rescue Department for personnel services for a total in-kind amount of \$17,754. This event will be funded in part from the District 12 in-kind reserve fund and in part from the non-ad valorem in-kind reserve of the fire rescue district budget.

In FY 2007-08, the Kids and Families Foundation, Inc. has received \$16,700 from the following District discretionary reserve funds: \$500 from District 1, \$500 from District 3, \$5,000 from District 6, \$500 from District 7, \$1,000 from District 9, \$2,700 from District 10, \$5,000 from District 11, and \$1,500 from District 13.
