

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE FIRE RESCUE DEPARTMENT AND THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE OCTOBER 4-5, 2008 “6TH ANNUAL SOUTH FLORIDA DRAGON BOAT FESTIVAL” SPONSORED BY UNITED CHINESE ASSOCIATION OF FLORIDA., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$10,000.00 TO BE FUNDED IN PART FROM THE DISTRICT 4 IN-KIND RESERVE FUND, AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT BUDGET

WHEREAS, the United Chinese Association of Florida, Inc. has requested in-kind services from the Miami-Dade Fire Rescue Department and Miami-Dade Park and Recreation Department for the October 4-5, 2008 “6th Annual South Florida Dragon Boat Festival” event in an amount not to exceed \$10,000.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the “6th Annual South Florida Dragon Boat Festival” event is to, among other things, promote a fun family festival through Dragon Boat races, raise funds to give back to the community, showcase South Florida’s diverse Asian American communities and to increase fitness and health awareness; and

WHEREAS, the United Chinese Association of Florida, Inc. is a not-for-profit organization; and

WHEREAS, the “6th Annual South Florida Dragon Boat Festival” is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$7,976.00 of the in-kind services shall be funded from the District 4 In-kind Reserve Fund and \$2,024.00 of

the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from Miami-Dade Park Recreation Department and the Miami-Dade Fire Rescue Department for the October 4-5, 2008 "6th Annual South Florida Dragon Boat Festival" in an amount not to exceed \$10,000.00 to be funded in part from the District 4 In-kind Reserve Fund and in part from the non-ad valorem portion of the Fire Rescue In-kind Reserve Fund.

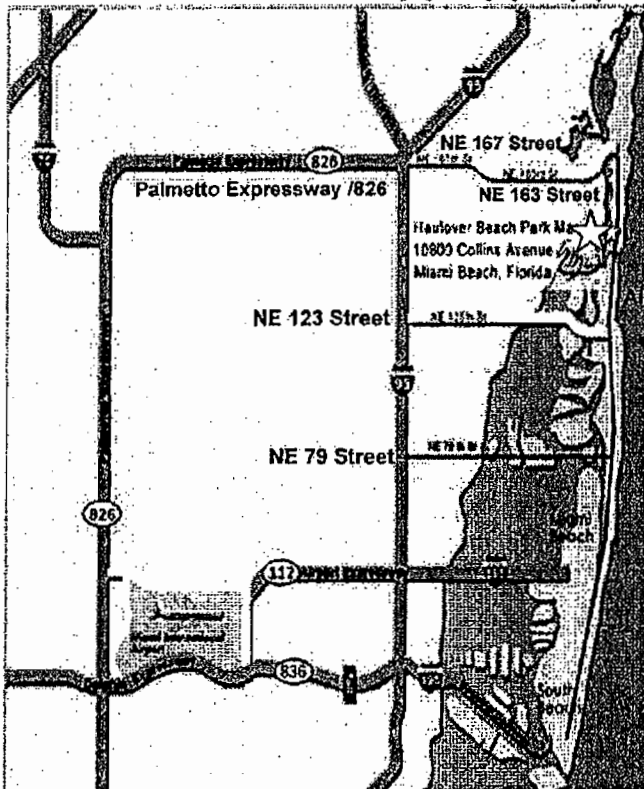

- Haulover Park & Marina will be two miles on the right hand side.**

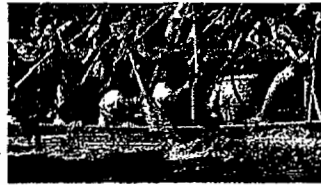

Subject: District In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the United Chinese Association of Florida, Inc. for their "6th Annual South Florida Dragon Boat Festival" held on October 4-5, 2008.

In-kind services have been requested in an amount not to exceed \$2,024 from the Miami-Dade Fire Rescue Department for personnel services and \$7,976 from the Miami-Dade Park and Recreation Department for 1 (one) show mobile, sound system, 2 (two) light towers and marine patrol services for a total in-kind amount of \$10,000. This event will be funded in part from the District 4 in-kind reserve fund and in part from the non-ad valorem portion of the fire rescue district in-kind reserve fund.

In FY 2008-09, the United Chinese Association of Florida, Inc. has received no county funding for this event.
